NARRATIVE

ON DECEMBER 16, 2024, AT APPROXIMATELY 0831 HOURS, OFFICERS RESPONDED TO A ROBBERY AT THE KFC LOCATED ON 100 MARKHAM PARK DRIVE. UPON ARRIVAL, TAVOQIOA DAY, 28 YO B/F DOB 10/18/1996, STATED THAT WHILE PREPARING TO OPEN THE STORE, SHE WAS APPROACHED BY AN UNKNOWN BLACK MALE SUSPECT WEARING A BLACK HOODIE, SKI MASK, AND DARK JOGGERS. THE SUSPECT, ESTIMATED TO BE IN HIS EARLY 20S, APPROXIMATELY 5 FOOT 9 INCHES TALL, AND SKINNY, DISPLAYED A SMALL FIREARM IN HIS WAISTBAND AND ORDERED HER TO THE SAFE. TAVOQIOA DAY COMPLIED, RETRIEVED THE MONEY FROM THE SAFE, AND PLACED IT IN A KFC BAG AS DIRECTED BY THE SUSPECT. THE SUSPECT THEN FLED THROUGH THE BACK DOOR, HEADING IN A WESTWARD DIRECTION TOWARD BOWMAN.

ACCORDING TO AUGUSTINE AVURN'S STATEMENT, 66 YO B/M DOB 8/17/1958, HE WAS OUTSIDE DISPOSING OF TRASH WHEN HE ENCOUNTERED THE SAME UNKNOWN BLACK MALE SUSPECT. THE SUSPECT DIRECTED HIM TO ENTER THE BUSINESS AND PROCEED TO THE SAFE. AVURN COMPLIED AFTER THE SUSPECT BRANDISHED THE FIREARM. ONCE INSIDE, THE SUSPECT'S ATTENTION SHIFTED TO TAVOQIOA DAY, WHILE AVURN WAS ORDERED TO THE OFFICE. HE NOTED THAT THE SUSPECT MIGHT HAVE ORIGINATED FROM A NEARBY MECHANIC SHOP.

TAVOQIOA DAY MENTIONED THAT THE SUSPECT WORE A SKI MASK AND WAS UNSURE ABOUT THE PRESENCE OF GLOVES. SHE DID NOT HAVE ACCESS TO THE CAMERA SYSTEM, BUT MANAGEMENT WOULD MAKE A COPY OF THE VIDEO SURVEILLANCE AVAILABLE.

ROBBERY DETECTIVES RESPONDED TO THE SCENE, AND A NORTHWEST SUPERVISOR HAS BEEN NOTIFIED. A BROADCAST OF THE INCIDENT WAS MADE TO ALL UNITS IN THE CITY.
