OFFICERS SPOKE WITH WITNESS#1 BEASLEY WHO STATED HE HEARD THE SHOT GO OFF BUT COULD NOT VISIBLY SEE WHAT HAPPENED DUE TO THE ALTERCATION OCCURRING ON THE OTHER SIDE OF THE VEHICLE. BEASLEY WENT OVER TO HELP VIC#1 WHITFIELD WHO WAS BLEEDING PROFUSELY FROM HIS LEFT ARM. BEASLEY USED SOME SORT OF FABRIC TO TIE ON HIS ARM AS A MAKE-SHIFT TOURNIQUET TO HELP WITH THE BLEEDING. WHITFIELD TOLD BEASLEY TO NOT CALL THE POLICE. WHITFIELD THEN GOT IN HIS CAR AND DROVE EAST ON 65TH STREET.

OFFICERS SPOKE WITH STORE CLERK PR#1 PANG WHO ADVISED BOTH WHITFIELD AND UNKNOWN SUSPECT CAME IN THE STORE. THE STORE CLERK BELIEVES WHITFIELD AND THE SUSPECT SPLIT FIVE DOLLARS EACH TO BUY A TEN DOLLAR LOTTERY TICKET. PANG STATED WHITFIELD THEN PURCHASED THE TICKET AND WON FIFTY DOLLARS FROM IT. PANG BELIEVES WHITFIELD WOULD NOT SPLIT THE MONEY WITH THE SUSPECT WHICH CAUSED THE DISPUTE.

OFFICERS OBSERVED ON THE SECURITY FOOTAGE, WHITFIELD AND SUSPECT ARGUING IN THE PARKING LOT. BOTH SUBJECTS GET CLOSE TO EACH OTHER, THEN SCUFFLE A BIT IN THE PARKING LOT, AND THEN WHITFIELD GETS SHOT IN HIS LEFT ARM. SUSPECT FLED ON FOOT NORTH ON LANCASTER AND WHITFIELD PROCEEDS TO GET IN HIS CAR AND DRIVE HOME WHERE HE HAD A RELATIVE DRIVE HIM TO THE HOSPITAL. OFFICERS WERE ABLE TO STOP THE VEHICLE AT 65TH AND UNIVERSITY WHERE WHITFIELD WAS THEN TRANSPORTED BY MEMS TO UAMS. WHITFIELD WAS LATER INTERVIEWED BY DETECTIVE AT THE HOSPITAL.

OFFICERS NOTIFIED A SERGEANT. CRIME SCENE AND DETECTIVE RESPONDED WHILE CRIME SCENE PROCESSED THE SCENE.
