### **NARRATIVE**

JUV1 ADVISED BRAYLON LEWIS WAS AN EMPLOYEE AT THE POPEYES AT THE LISTED LOCATION UNTIL HE WAS TERMINATED EARLIER IN THE YEAR. JUV1 ADVISED HE RECOGNIZED BRAYLON LEWIS WHEN HE APPROACHED HIM AS HE WAS UNLOCKING THE DOOR TO THE BUSINESS. JUV1 ADVISED MR. LEWIS PUT A GUN, DESCRIBED AS A GLOCK, TO HIS BACK AND TOLD HIM TO ENTER THE RESTAURANT. JUV1 ADVISED MR. LEWIS TOLD HIM TO OPEN THE SAFE AND HE COMPLIED. MR. LEWIS THEN TOOK MONEY AND LEFT THE BUSINESS IN AN UNKNOWN DIRECTION OF TRAVEL. OFFICER PRINCE MADE A BROADCAST REGARDING THE INCIDENT. DETECTIVES RESPONDED TO THE SCENE TO VIEW SECURITY FOOTAGE AND CONDUCT INTERVIEWS. I OBSERVED FOOTAGE OF A BLACK MALE WITH A GRAY HOODIE, A SKI MASK, BLACK PANTS AND GRAY GLOVES POINTING A BLACK HANDGUN AT THE BACK OF JUV1. THE TIME STAMP ON THE VIDEO WAS 0801 HOURS, HOWEVER, JUV1 DID NOT CALL POLICE UNTIL 0840 HOURS. MVR/BWC IN USE.
