THE VEHICLES GLASS HAD BEEN SHATTERED, MULTIPLE BULLET HOLES THROUGH THE VEHICLE, BLOOD IN THE DRIVER SEAT AREA, AND AIRBAGS DEPLOYED. WILLIAMS' BELONGINGS WERE BAGGED AS EVIDENCE AND LATER STORED IN THE 12TH ST PROPERTY ROOM. MVR AND BWC IN USE

ROBINSON ADVISED THAT HE WAS ASLEEP ON THE COUCH AT THE LISTED LOCATION WHEN HE WAS AWOKEN BY WALKER. WALKER ALLEGEDLY POINTED A FIREARM AT ROBINSON AND STOLE HIS GOLD WATCH.
