NARRATIVE

OFFICERS RESPONDED TO THE LISTED ADDRESS FOR A BATTERY CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH EVANS. EVANS ADVISED HE WORKS FOR ASSET PROTECTION AT THE LISTED BUSINESS.

EVANS ADVISED HE OBSERVED TWO BLACK FEMALES CONCEALING THE LISTED ITEMS AND ATTEMPTING TO LEAVE THE BUSINESS. WHEN EVANS APPROACHED THE SUSPECTS AND ATTEMPTED TO TAKE THE ITEMS, ONE OF THE SUSPECTS RAN AND THE OTHER SUSPECT BEGAN TO PUSH AND PUNCH AT EVANS AND OTHER SECURITY PERSONNEL. OFFICERS DID NOT OBSERVE ANY INJURY ON THE SECURITY PERSONNEL.

EVANS ADVISED SHORTLY AFTER THE ALTERCATION BOTH SUSPECTS FLED THE SCENE IN THE LISTED VEHICLE EAST ON BASELINE ROAD.
