PRADO ADVISED SHE FOLLOWED HIM OUTSIDE TELLING HIM HE HAD TO PAY FOR THE \$2500.00 DENTAL BRIDGE. MR. ATTIA (WITNESS 1), ADVISED HE FOLLOWED MR. BAYLESS OUTSIDE TO VEHICLE 1, WHERE HE SAW MR. CARCANO, GRABBED HER BY HER JACKET AND TOLD HER TO EMPTY HER POCKETS. MS. CARCANO STATED SHE DID NOT HAVE ANYTHING BUT QUARTERS. THE SUSPECT THEN THREW A LAUNDRY BASKET AT HER LEG.

MR. COOLE WORKS AT THE FUNWASH AND STATED THE SUSPECT ENTERED THE BUSINESS ACCUSING PEOPLE OF STEALING HIS CELL PHONE. MR. COOLE STATED THE SUSPECT THREW A CHAIR AT HIM BUT MISSED. MR.
