#### **NARRATIVE**

OFFICERS RESPONDED TO 1501 WEST ROOSEVELT FOR AN ASSIST MEDICAL. UPON ARRIVAL OFFICERS MADE CONTACT WITH CARLOS JOHNSON. JOHNSON HAD A SEVERE LACERATION TO HIS HAND OFFICERS PROVIDED GAUZE UNTIL MEMS ARRIVED. JOHNSON ADVISED HE WAS ABOUT A BLOCK EAST DOWN FROM 1501 ROOSEVELT WHERE HE WAS WALKING TO GET BACK TO WARMING CENTER AT THE DUNBAR COMMUNITY CENTER. JOHNSON ADVISED WHILE HE WAS WALKING AN UNKNOWN MALE IN DARK CLOTHING TRIED TO TAKE HIS BAG AND STATED " GIVE ME WHAT YO GOT " JOHNSON ADVISED HE SAID NO AS HE WAS TRYING TO PULL HIS BAG BACK. JOHNSON ADVISED THE UNKNOWN MALE PULLED OUT A KNIFE AND SWUNG IT AT HIM, JOHNSON STATED HE PUT HIS HAND UP TO BLOCK AND WAS CUT. JOHNSON STATED HE TRIED WRESTLING THE KNIFE FROM THE UNKNOWN MALE BEFORE REALIZING HE WAS CUT. JOHNSON STATED HE RAN OFF TOWARD THE GAS STATION AT 1501 ROOSEVELT TO CALL FOR AN AMBULANCE. JOHNSON WAS TRANSPORTED TO UAMS WHERE HE WAS TREATED FOR HIS INJURIES. SUPERVISOR WAS NOTIFIED DURING THE INCIDENT. THERE WAS A BLOOD TRAIL LEADING TO THE STORE BUT WAS DISAPPEARING FURTHER OFF DUE TO IT SNOWING HEAVILY SO OFFICERS WERE NOT ABLE TO LOCATE ANY CRIME SCENE. OFFICERS FOLLOWED MEMS TO UAMS TO TRY AND OBTAIN MORE INFORMATION. OFFICERS MADE CONTACT WITH JOHNSON AGAIN IN THE TRAUMA ROOM TO TRY AND GET MORE INFORMATION ABOUT THE SUSPECT AND GET A BETTER DESCRIPTION, BUT THE ONLY THING HE KNEW WAS HE HAD ON DARK COLORED CLOTHING OF AN UNKNOWN EXACT COLOR.

#### **NARRATIVE**

OFFICERS WERE DISPATCHED TO A SHOOTING JUST OCCURRED. WHILE EN ROUTE OFFICERS WERE PROVIDED WITH THE SUSPECT VEHICLE INFORMATION. UPON ARRIVAL, OFFICERS OBSERVED THE SUSPECT VEHICLE IN THE PARKING LOT, OFFICERS CONDUCTED A FELONY TAKE DOWN ON THE VEHICLE AND PLACED, LAITH STAFFORD, AND, LOREN STAFFORD, INTO CUSTODY. OFFICERS THEN BEGAN GIVING THE VICTIM, KERVIN NELSON, LIFE SAVING EMERGENCY TREATMENT. MR. NELSON WAS SUFFERING FROM MULTIPLE GUNSHOT WOUNDS TO THE STOMACH AND ARMS. MEMS ARRIVED ON SCENE AND TRANSPORTED MR. NELSON TO UAMS. OFFICERS ON SCENE WERE ADVISED THAT MR. STAFFORD HAD SHOT MR. NELSON AFTER A VERBAL ALTERCATION. MR. NELSON HAD ATTEMPTED TO DEESCALATE THE SITUATION TO WHICH MR. STAFFORD SHOT HIM MULTIPLE TIMES FOR. MR. STAFFORD'S VEHICLE WAS TOWED TO THE CRIME SCENE BAY FOR PROCESSING. MAJOR CRIMES AND A NORTHWEST SUPERVISOR WERE NOTIFIED. THERE WERE MULTIPLE WITNESSES ON SCENE INCLUDING, COURTNEY BINZ, AND ALLYSA NELSON. BOTH WITNESSES WERE TRANSPORTED TO THE 12TH STREET DETECTIVES OFFICE FOR AN INTERVIEW WITH DETECTIVES. ETHAN CAVANAUGH, AND JESSICA COATES, WERE ALSO ON SCENE, BUT STATED THEY ARRIVED ON SCENE AFTER THE SHOOTING. BOTH SUBJECTS WERE TRANSPORTED TO THE 12TH STREET DO FOR INTERVIEWS. ONCE ALL INTERVIEWS WERE COMPLETE ALL WITNESSES AND CONTACTS WERE TRANSPORTED BACK TO THEIR DESIRED LOCATION. AFTER THE INVESTIGATION WAS COMPLETED BY DETECTIVES MR. ### **NARRATIVE**

OFFICERS WERE EN ROUTE TO A SHOTS FIRED CALL AT THE LISTED ADDRESS. OFFICERS WERE ADVISED THE ORIGINAL COMPLAINANT DID NOT WANT CONTACT. OFFICERS WERE ADVISED OF AN ADDITIONAL FROM A CALLER FROM 6115 DENHAM DRIVE WHO REPORTED THAT A BULLET ENTERED HIS HOME.

OFFICERS ARRIVED AT 6115 DENHAM DRIVE. OFFICERS MADE CONTACT WITH THE CALLER, ERUIN ICAL. MR. ICAL ADVISED HE HEARD A SOUND COMING FROM THE KITCHEN, WHICH AT FIRST HE THOUGHT WAS AN ANIMAL THAT GOT INSIDE THE HOUSE. MR. ICAL FURTHER ADVISED HE WENT TO CHECK ON THE CONDITION OF HIS FAMILY MEMBERS WHO ARE THE OTHER LISTED VICTIMS AND WHO WERE IN THE HOUSE AT TIME OF THE INCIDENT. MR. ### **NARRATIVE**

OFFICERS RESPONDED TO A BATTERY CALL AT THE LISTED ADDRESS AND MADE CONTACT WITH THE CALLER, SALVADORE SARATE. MR. SARATE STATED A WHITE MALE WAS ON HIS BACK PORCH IN ONLY HIS UNDERWEAR AND HAD BEEN ASSAULTED. OFFICERS MADE CONTACT WITH CODY ONEAL, WHO HAD BRUISES ON HIS LEGS, ARMS AND FACE. HE HAD SMALL LACERATIONS ON HIS HANDS AND FACE. MEMS ARRIVED ON SCENE AND TREATED MR. ONEAL BUT HE REFUSED TRANSPORT.

MR. ONEAL STATED HE WAS ACROSS THE STREET AT 9 VALLEY CT., AND STAYED THE NIGHT WITH A FRIEND, TAYLOR PENNINGTON. MR. ONEAL STATED WHEN HE WOKE UP, THREE MASKED MEN ASKED HIM WHY HE WAS IN THE HOUSE AND IN BED WITH MS. PENNINGTON AND TOLD HIM TO GIVE THEM HIS MONEY. MR. ONEAL STATED THE THREE SUSPECTS HIT HIM ALL OVER HIS BODY WITH WHAT HE BELIEVED WAS A LEAD OR METAL PIPE. MR. ONEAL STATED HE KNEW A MAN WHO HE KNOWS AS "BISHOP" WAS NOW AT THE HOUSE BECAUSE HE COULD HEAR HIS VOICE IN ANOTHER ROOM. MR. ONEAL STATED THE MEN TOOK HIS MONEY AND HE RAN FROM THE HOUSE ACROSS THE STREET TO MR. SARATE'S HOUSE. MR. ONEAL DOES NOT LIVE AT THE ADDRESS OR KNOW MR. SARATE.

OFFICERS MADE CONTACT WITH MS. PENNINGTON, WHO STATED MR. ONEAL WAS NOT GIVEN PERMISSION TO LAY IN HER BED AND HE MUST HAVE LAID DOWN AFTER SHE FELL ASLEEP. MS. PENNINGTON STATED SHE WAS AWAKEN BY HER AUNT, AMANDA MULLIN, WHO ASKED HER IF SHE KNEW MR. ONEAL WAS IN BED WITH HER. MS. PENNINGTON STATED MR. ONEAL WAS HOLDING HER TIGHT WHILE HE WAS SLEEPING BUT SHE WAS NOT ASSAULTED. MS. PENNINGTON STATED SHE LEFT THE ROOM WHEN MR. ONEAL WOKE UP, AND WAS TOLD BY MS. MULLIN THAT MR. ONEAL FELL WHILE HE WAS LEAVING THE ROOM. MS.PENNINGTON STATED SHE WAS UNAWARE OF ANY MASKED MEN IN THE HOUSE. SHE STATED ONLY HERSELF, MS. MULLIN, MR. ONEAL, AND "BISHOP" WERE IN THE HOUSE WHEN MR. ONEAL LEFT.

OFFICERS MADE CONTACT WITH MS. MULLIN, WHO STATED NO MASKED MEN ENTERED THE HOUSE AT ANY TIME. MS. MULLIN STATED SHE TOLD MR. ONEAL TO LEAVE AND SHE WAS UNAWARE HE LEFT WITHOUT HIS CLOTHES OR BELONGINGS. MS. PENNINGTON AND MS. MULLEN WOULD NOT ALLOW OFFICERS PERMISSION TO ENTER THE HOUSE, BUT THEY DID BRING OFFICERS ME. ONEAL'S CLOTHES AND BOOTS.

OFFICERS TRANSPORTED MR. ONEAL TO WHERE HE LEFT HIS LISTED 2014 CHEVY EQUINOX AND THE VEHICLE WAS NO LONGER THERE. MR. ONEAL STATED THE SUSPECTS MUST HAVE STOLEN HIS CAR KEYS AND TAKEN THE VEHICLE. TOW LOGS WERE CHECKED WITH NEGATIVE RESULTS. A STOLEN VEHICLE BROADCAST WAS MADE ON MAIN CHANNEL AND THE VEHICLE WAS ENTERED INTO ACIC VIA EMAIL. BWC WAS IN USE.

### **NARRATIVE**

WHILE ON PATROL, I WAS DISPATCHED TO THE LISTED ADDRESS IN REGARD TO A ROBBERY OF AN INDIVIDUAL CALL.

UPON ARRIVAL, I MADE CONTACT WITH VIC#1 (BELL).

BELL ADVISED A BLACK FEMALE AND 2 BLACK MALES APPROACHED HIM AT A HOUSE HE WAS WORKING AT NEAR 28TH AND WASHINGTON. BELL ADVISED THE 3 SUSPECTS WERE DRIVING VEH#1. BELL ADVISED ONE OF THE BLACK MALES CAME TOWARD HIM AND DEMANDED HIS WALLET. BELL ADVISED ONE OF THE BLACK MALES TOOK HIS WALLET FROM HIS LEFT FRONT POCKET, THEY THEN GOT INTO VEH#1 AND FLED. BELL ADVISED HE FOLLOWED VEH#1 IN HIS VEHICLE. BELL'S VEHICLE IS VEH#2. BELL ADVISED AS HE WAS FOLLOWING VEH#1, VEH#1 SUDDENLY STOPPED AND HE SLIGHTLY COLLIDED WITH VEH#1. BELL ADVISED THE COLLISION WAS ON ASHER AVENUE. NEAR AN UNKNOWN INTERSECTION.

BELL ADVISED VEH#1 THEN SUDDENLY STOPPED IN THE FRONT YARD OF 2522 MAPLE STREET. BELL ADVISED HE STOPPED HIS VEHICLE NEXT TO VEH#1. BELL ADVISED SUSP#1 (FLOWERS) EXITED VEH#1 AND OPENED THE FRONT PASSENGER DOOR OF HIS VEHICLE. BELL ADVISED SUSP#1 (FLOWERS) THEN ENTERED HIS VEHICLE, GRABBED THE GEAR SHIFTER AND TOOK THE KEYS OUT OF THE IGNITION.

BELL ADVISED THE 2 BLACK MALES OPENED THE DRIVER DOOR TO HIS VEHICLE. BELL ADVISED THE 2 BLACK MALES GRABBED HIM, PULLED HIM OUT OF HIS VEHICLE AND BEGAN ASSAULTING HIM. BELL ADVISED THE FIGHT CONTINUED ONTO MAPLE STREET.

BELL ADVISED ONE OF THE BLACK MALES HIT HIM ON HIS FOREHEAD WITH A PISTOL. BELL ADVISED HE FELL TO THE GROUND AND FELT A PISTOL PRESSED AGAINST THE BACK OF HIS HEAD. BELL ADVISED ONE OF THE BLACK MALES TOLD HIM "UNLOCK YOUR PHONE OR I WILL KILL YOU". BELL ADVISED THE 2 BLACK MALES WERE PUNCHING AND KICKING HIM WHILE HE WAS ON THE GROUND AND THEN TOOK HIS CELL PHONE. BELL ADVISED FLOWERS ENTERED THE DRIVER SEAT OF VEH#1 AND THE 2 BLACK MALES ALSO ENTERED VEH#1. BELL ADVISED THE 3 SUSPECTS FLED THE AREA NORTHBOUND ON MAPLE STREET IN VEH#1. BELL WAS BLEEDING FROM VARIOUS AREAS OF HIS FACE. BELLS LEFT EYE SOCKET WAS SWOLLEN AND HE APPEARED TO HAVE A BROKEN NOSE. BELL ADVISED HE ALSO HAD HIP PAIN FROM THE ASSAULT. MEM'S WAS ADVISED AND ARRIVED ON SCENE. MEMS TRANSPORTED BELL TO UAMS.

OFFICER K. MORRIS BEGAN FINGERPRINTING VEH#2 TO RETRIEVE SUSPECT FINGERPRINTS FROM BELLS VEHICLE. OFFICER K. MORRIS OBTAINED SEVERAL FINGERPRINTS FROM VEHICLE2.

I MADE CONTACT WITH WIT#1 (RAMOS). RAMOS ADVISED HE WAS IN HIS BACKYARD AND HEARD A LOUD VERBAL DISTURBANCE COMING FROM MAPLE STREET. RAMOS ADVISED HE OBSERVED VEH#1 AND VEH#2 IN THE FRONT YARD OF 2522 MAPLE STREET. RAMOS ADVISED HE OBSERVED 2 BLACK MALES BEATING BELL WHILE THEY WERE ON THE GROUND. RAMOS ADVISED HE THEN BEGAN RECORDING THE INCIDENT ON HIS PHONE.

I OBSERVED THE 2 VIDEO CLIPS RAMOS RECORDED. I OBSERVED FLOWERS ENTER VEH#1 AND DRIVING IN FRONT OF VEH#2. ONE OF THE BLACK MALES YELLED TO THE FEMALE "GET IN THE CAR SIS". AS FLOWERS PARKED VEH#1 IN FRONT OF VEH#2, I COULD SEE A PHYSICAL ASSAULT OCCURRING ON THE PASSENGER SIDE OF VEH#2. OFFICERS TAYLOR, TALBERT, BAXTER AND NATIVI LOCATED VEH#1 AT 8701 WEST MARKHAM AT THE OREILLY AUTO PARTS STORE. OFFICERS LOCATED SUSP#1, FLOWERS, STANDING NEXT TO VEH#1. OFFICERS TOOK FLOWERS INTO CUSTODY AS SHE MATCHED THE DESCRIPTION GIVEN BY BELL. FLOWERS WAS TRANSPORTED TO THE 12TH STREET SUBSTATION.

OFFICER TAYLOR OBSERVED DODGE KEYS, APPEARING TO BE FROM VEH#2, IN THE DRIVER SEAT OF VEH#1. THE DODGE KEYS WERE OBSERVED IN PLAIN VIEW. OFFICER TAYLOR LOCATED A BROWN MCDONALDS PAPER BAG SITTING ON TOP OF VEH#1.

INSIDE THE MCDONALDS BAG WAS THE LISTED STOLEN ITEMS FROM THE WALLET BELONGING TO BELL. THE WALLET ITSELF WAS NOT LOCATED IN THE BAG. ALSO IN THE BAG WAS A PLASTIC BAGGIE CONTAINING A GREEN VEGGIE MATTER APPEARING TO BE MARIJUANA.

VEH#1 WAS TOWED TO THE CRIME SCENE BAY. THE SUSPECTED MARIJUANA WAS STORED AT THE SUBSTATION. FLOWERS WAS TRANSPORTED TO PCRJ. FLOWERS WAS CHARGED WITH AGGRAVATED ROBBERY, BATTERY 2ND, THEFT OF PROPERTY AND POSSESSION OF MARIJUANA. UNIT #20C642.
