NARRATIVE

OFFICER SILVA, HILGEMAN, GRIFFIN AND I RESPONDED TO THE LISTED LOCATION, IN REFERENCE TO A TERRORISTIC ACT. UPON ARRIVAL, WE MADE CONTACT WITH VIC-1/SUSP-2(DEVONTE PATTERSON B/M) AND HIS GIRLFRIEND VIC-2(PORSHA WILLIAMS B/F) WHO STATED, THEY WERE AT THE VAPE SHOP WHEN SUSP-1/VIC-3 (JOSEPH JENNINGS W/M) STARTED A CONFRONTATION WITH THEM, CURSING THEM AND YELLING RACIAL SLURS. AFTERWHICH, THEY LEFT AND AS THEY DROVE PAST MR. JENNINGS VEHICLE MR. PATTERSON SAID MR. JENNINGS SHOT AT HIM AND HE RECORDED IT. MR. PATTERSON PROVIDED FOOTAGE SHOWING MR. JENNINGS HANGING OUT OF THE PASSENGER SIDE OF V-1 AND YOU CAN HEAR A POP IN THE BACKGROUND. AFTER TAKING THE REPORT AND LEAVING THE SCENE, MR. PATTERSON CALLED BACK INTO DISPATCH STATING HE HAD FOUND THE SUSPECTS HOME BY JUST DRIVING AROUND IN THE AREA.
