## NARRATIVE

OFFICERS MADE CONTACT WITH VICTIM 1, MS. BRIANA CODY. MS. CODY'S STATEMENT WAS CONGRUENT WITH JUVENILE 1. MS. CODY ADVISED SUSPECT 1 POSSIBLY SHOT 4 TO 5 ROUNDS IN THEIR DIRECTION. MS. CODY ADVISED SHE SAW SUSPECT 1 RUN INTO THE SOUTH OAKS APARTMENTS AFTER HE FIRED THE LAST ROUND. SHE STATED HER VEHICLE WAS NOT STRUCK BY ANY OF THE ROUNDS. OFFICERS OBSERVED NO SIGNS OF DAMAGE CAUSED BY THIS INCIDENT TO MS. CODY'S VEHICLE. ALL INVOLVING PARTIES ADVISED THEY DID NOT NEED ANY MEDICAL ATTENTION.
