OFFICERS RESPONDED TO A DISTURBANCE WITH A WEAPON AT THE LISTED LOCATION. PRIOR TO OFFICERS ARRIVAL OFFICERS WERE ADVISED OF NUMEROUS SHOTS FIRED CALLS AT THE LISTED LOCATION. OFFICERS WERE ADVISED OF SEVERAL SUBJECTS TRYING TO FIGHT SOMEONE. OFFICERS WERE FLAGGED DOWN BY MR. HERNANDEZ WHO ADVISED HIS VEHICLE WAS SHOT AT BY AN UNKNOWN SUBJECT WHILE HE WAS IN IT AT THE LISTED LOCATION. MR. HERNANDEZ ADVISED THERE SEVERAL SUBJECTS TRYING TO FIGHT SOMEONE AND A FEW MINUTES LATER HE STARTED HEARING GUN SHOTS. MR. HERNANDEZ ADVISED WHEN HIS VEHICLE GOT HIT BY A BULLET HE LEFT THE LOCATION. OFFICERS MET MR. HERNANDEZ AT 11715 RAINWOOD RD. OFFICERS OBSERVED A BULLET HOLE IN THE LEFT REAR CORNER PANEL. REAR WINDOW, AND THE RIGHT REAR PASSENGER WINDOW. OFFICERS OBSERVED BULLET HOLES IN APARTMENT 184 AND APARTMENT 185. OFFICERS MADE CONTACT WITH MR. PERRYMON AND MS. ROGERS WHO ADVISED THEY DIDN'T KNOW ANYTHING DEALING WITH THE GUNSHOTS. MS.
