




SUBJECT: SALES AND USE TAX COLLECTIONS UPDATE

Sales and use tax collections for January 2025 have been tabulated. The January 2025 collections are for sales that occurred in the month of November 2024. The chart below compares the current tax totals to the 2024 adopted budget and to collections made in the same periods one year ago.

January 2025 sales and use tax collections of November 2024 revenues are 2.38% or \$292,162 lower than the same month one year ago, and 2.97% or \$366,734 lower than the budget. The components of the net unfavorable budget variance for the month were attributed to the City's share of the County 1% tax which had an unfavorable variance of 4.81%; the City's 1 1/8-cent operating tax which had an unfavorable variance of 1.60%; and the State Turnback allocation which had an unfavorable variance of 1.16%. Year-to-date sales tax revenues are 0.53% lower than the same period a year ago and 1.13% below the adopted budget with one month remaining in the fiscal year.

Sales and use tax collections for the twelve (12) months ended January 2025 and January 2024 were \$141,726,903 compared to \$142,290,127, respectively. The FY24 Budget estimated total sales and use collections at \$143,278,161 or \$1,551,258 more than the amount collected in the most recent twelve (12) months.

In January 2024, the City received \$201,981 in State Turnback funds from the surplus of the Property Tax Relief Fund. For this report, the distribution has been prorated over a twelve (12) month period. If additional information is needed, please advise.
