NARRATIVE

ALFORD STATED THAT ON 01/31/2025, AT APPROXIMATELY 0600 HOURS, AN UNKNOWN FEMALE SUSPECT CAME FROM 11405 MARA LYNN ROAD APT#8. ALFORD STATED THAT THE FEMALE SUSPECT BROUGHT HIM BISCUITS, AND HE LET HER INSIDE OF HIS APARTMENT. ALFORD DESCRIBED THE SUSPECT AS A BLACK FEMALE, SHORT, WITH LONG BLACK HAIR.

ALFORD STATED THAT A SHORT TIME LATER, THE FEMALE SUSPECT UNLOCKED THE FRONT DOOR TO HIS APARTMENT. ALFORD STATED THAT TWO UNKNOWN MALE SUSPECTS OPENED THE DOOR AND ENTERED HIS APARTMENT. ALFORD DESCRIBED THE FIRST SUSPECT AS A BLACK MALE, TALL, WITH A BEARD AND WEARING A GRAY HOODIE. ALFORD DESCRIBED THE SECOND SUSPECT AS A BLACK MALE, SHORT, AND WEARING A RED HOODIE

ALFORD STATED THAT THE MALE SUSPECT HAD HIS HAND IN HIS HOODIE, GIVING THE APPEARANCE THAT HE HAD A GUN. ALFORD STATED THAT ONE OF THE SUSPECTS PUNCHED HIM IN THE NOSE, AND HE WAS STRUCK ON HIS LEFT FOREARM. ALFORD STATED THAT THE TWO MALE SUSPECTS TOOK HIS PLAYSTATION 5, AND ALL THREE SUSPECTS LEFT HIS APARTMENT. ALFORD STATED THAT ALL THREE SUSPECTS ENTERED APARTMENT #8. OFFICERS WALKED DOWNSTAIRS TO APARMTENT #8, THE DOOR WAS LOCKED AND NO LIGHTS WERE ON INSIDE OF THE RESIDENCE. THERE WERE NO SIGNS THAT THE APARTMENT WAS OCCUPIED. OFFICERS KNOCKED ON THE DOOR AND ANNOUNCED THEMSELVES MULTIPLE TIMES WITH NO RESPONSE.

OFFICERS INSPECTED ALFORD FOR ANY SIGNS OF PHYSICAL INJURIES. THERE WAS NO SIGNS OF REDNESS, SWELLING, BRUISING OR BLOOD, WHERE ALFORD STATED THAT HE WAS PUNCHED ON THE NOSE. OFFICERS DID NOT OBSERVE ANY SIGNS OF PHYSICAL INJURY UPON INITIAL INSPECTION OF HIS LEFT FOREARM.

NARRATIVE

OFFICERS RESPONDED TO BAPTIST HEALTH HOSPITAL FOR AN UNKNOWN TROUBLE CALL. EN ROUTE, OFFICERS WERE ADVISED THAT THE CALLER HAD BEEN SHOT AND WAS DRIVING HIMSELF TO THE HOSPITAL. ON SCENE, OFFICERS MADE CONTACT WITH JAKARIE WOODLEY. HE ADVISED THAT HE WAS DRIVING TO HIS COUSIN'S RESIDENCE AND HIS GPS WAS TAKING HIM DOWN WHITFIELD STREET. AS HE WAS TRAVELING DOWN WHITFIELD STREET, HE RECOGNIZED A HOUSE THAT HE STATED HIS GIRLFRIEND, ALLIYAH KING, HAD BEEN ATTACKED AT BY & GROUP OF FEMALES A COUPLE OF WEEKS PRIOR. HE STATED THAT HE GOT OUT OF HIS VEHICLE TO TAKE A PICTURE OF THE HOUSE AND AS HE RETURNED TO THE VEHICLE AND STARTED DRIVING AWAY, HE NOTICED A BLACK MALE WEARING A WHITE SHIRT WALK OUT ONTO THE PORCH. MR. WOODLEY ADVISED THAT HE HEARD A LOUD POP AND FELT A SHARP PAIN IN HIS BACK AND SHOULDER. HE STATED THAT HE IMMEDIATELY REALIZED HE HAD BEEN SHOT AND STARTED DRIVING TO BAPTIST HOSPITAL. MR. WOODLEY STATED THAT OFFICERS NEEDED TO CONTACT MS. KING BECAUSE "SHE WOULD KNOW WHO SHOT HIM".

AT THE FRONT OF THE EMERGENCY ROOM ENTRANCE, OFFICERS OBSERVED THE VEHICLE THAT MR. WOODLEY HAD BEEN DRIVING. THE VEHICLE WAS TOWED TO THE CRIME SCENE BAY. MS. KING ARRIVED AT THE BAPTIST HEALTH EMERGENCY WAITING ROOM WHERE SHE WAS LATER INTERVIEWED BY DETECTIVES.

UPON ARRIVAL, THE EMPLOYEE ADVISED THAT THE STORE WAS NOT GETTING ROBBED, BUT A HOMELESS MAN CAME IN A STATED HE WAS ROBBED. OFFICERS MADE CONTACT WITH THE SUBJECT WHO WAS IDENTIFIED AS FRED RUCKER. RUCKER ADVISED THAT WHILE HE WAS IN THE WOODS AT HIS HOMELESS CAMP A BLACK MALE SUBJECT NAMED PHARAOH HIT HIM IN THE HEAD WITH A METAL POLE AND TOOK HIS BACKPACK. RUCKER WAS GIVEN AN INCIDENT NUMBER.

RUCKER WAS TRANSPORTED BY MEMS UNIT 339 TO UAMS.

DUE TO LACK OF ACCURATE INFORMATION A BROADCAST WAS NOT MADE.

BWC/MVR IN USE.

OFFICERS RESPONDED TO UAMS HOSPITAL ER FOR A THEFT OF PROPERTY REPORT. UPON ARRIVAL, OFFICERS MADE CONTACT WITH MR. FRED LEE RUCKER(09/08/1955). RUCKER ADVISED OF THE SAME INCIDENT THAT OCCURRED ABOVE WITH ONE DIFFERENCE BEING RUCKER STATED THE NAME OF THE BLACK MALE SUSPECT WAS POSSIBLY CARLOS. RUCKER ADVISED HE DID NOT KNOW CARLOS, NOR DID HE REMEMBER WHAT HE WAS WEARING. RUCKER STATED CARLOS APPEARED TO BE IN HIS 40S. THE MENTIONED PROPERTY WAS ADDED TO THIS REPORT UNDER THE PROPERTY TAB. OFFICERS DID NOT OBSERVE ANY INJURY ON LEE'S HEAD OR NECK.
