NARRATIVE

OFFICERS RESPONDED TO A SHOOTING AT 2619 BARBER STREET. OFFICERS MADE CONTACT WITH MARKITA CLEMMONS. SHE ADVISED SOMEONE SHOT AT HER HOUSE. SHE ADVISED HER MOTHER, BRIDGETTE BAILEY, HAD BEEN POSTING VIDEOS ON FACEBOOK TALKING BAD ABOUT HER. SHE ADVISED THE HOUSE GOT SHOT BETWEEN APPROXIMATELY 1900 - 1911 HOURS ON TODAYS DATE, 02/04/2025. CLEMMONS ADVISED SHE DID NOT SEE ANYONE WHEN THE SHOTS WERE FIRED INTO HER HOME. SHE ADVISED SHE GOT ON THE FLOOR AS SOON AS SHE HEARD GUN SHOTS. OFFICERS OBSERVED MULTIPLE BULLET HOLES THROUGHOUT THE FRONT OF THE HOUSE AND ONE IN THE SIDE OF A VEHICLE IN THE DRIVEWAY. OFFICERS ALSO LOCATED MULTIPLE SHELL CASINGS IN THE STREET IN FRONT OF HER RESIDENCE. OFFICERS WERE ADVISED MS. CLEMMONS' NEPHEW, LISTED JUVENILE, WAS IN THE RESIDENCE WHEN THE INCIDENT OCCURRED. OFFICERS ASKED MS. CLEMMONS IF SHE AND HER NEPHEW WERE INJURED. SHE ADVISED THEY WERE NOT. OFFICERS OBSERVED BOTH VICTIMS AND THEY SHOWED NO VISIBLE INJURIES. OFFICERS LATER FOUND MS. CLEMMONS CALLED EARLIER IN THE DAY REGARDING A DISTURBANCE (2025-014878) WITH HER MOTHER, BEFORE THE SHOOTING HAD OCCURRED. CLEMMONS BELIEVES HER MOTHER WAS THE SUSPECT IN THIS INCIDENT BUT IS NOT SURE. OFFICERS NOTIFIED A SUPERVISOR AND MAJOR CRIMES DETECTIVES WHO BOTH RESPONDED TO THE SCENE.
