**NARRATIVE**

OFFICERS WERE WORKING OFF DUTY WHEN OFFICERS AND ASSET PROTECTION OBSERVED SUBJECTS RUNNING IN THE PARKING LOT OF WALMART. UPON MAKING CONTACT WITH THE VEHICLE STILL IN THE PARKING LOT, OFFICERS TOLD THE DRIVER, MARTIN JASSO, TO STOP AND EXIT THE VEHICLE. AFTER MR. JASSO DID NOT EXIT THE VEHICLE OFFICERS ATTEMPTED A FELONY TAKE DOWN. OFFICERS TOOK POSSESSION OF THE KEYS OF THE VEHICLE AND MR. JASSO STARTED TO COMPLY. MR. JASSO ADVISED HE DID NOT KNOW SUSPECT, ADRIANNE OTIS, SHE ONLY ASKED HIM FOR A RIDE.

MRS. OTIS WAS IN THE PASSENGER SEAT ADVISING THE BANK ROBBED HER AND SHE WAS NOT GETTING OUT OF THE VEHICLE. OFFICERS OPENED THE PASSENGER DOOR AND PULLED HER OUT THE VEHICLE AFTER SHE REFUSED TO LISTEN TO VERBAL COMMANDS. OFFICERS CONDUCTED A ARM BAR TAKE DOWN AFTER MRS. OTIS PULLED AWAY FROM OFFICERS. AS OFFICERS WERE ATTEMPTING TO PRY HER HANDS OPEN, OFFICERS OBSERVED MULTIPLE 100-DOLLAR BILLS IN HER HAND. MRS. OTIS WAS THEN TAKEN INTO CUSTODY. AFTER TAKING HER INTO CUSTODY SHE ADVISED, ILL ADMIT I PRETENDED I HAD A GUN.

OFFICERS NOTIFIED A SUPERVISOR AND MAJOR CRIMES OF THE SITUATION. OFFICERS MADE CONTACT WITH MR. MCLIN AND BANK TELLER WHITNEY B, WHO ADVISED MRS. OTIS ENTERED THE BANK AND GAVE THEM A NOTE STATING TO NOT SAY A WORD AND PUT ALL THE MONEY FROM THE REGISTER IN THE BAG OR ILL SHOOT YOUR HEAD OFF. MR. MCLIN ADVISED AFTER HE SEEN MRS. OTIS PRETENDING, SHE HAD A FIREARM HE ADVISED THIS ISN'T WHAT YOU WANT. MR. MCLIN ADVISED MRS. OTIS STATED TO PUT THE MONEY IN THE BAG OR ILL BLOW YOUR HEAD OFF VERBALLY. MR. MCLIN ADVISED AFTER HE SEEN A SPRAY BOTTLE IN HER JACKET THEY BEGAN TAKING MONEY OUT OF THE REGISTER. MRS. OTIS THEN TOOK AN UNKNOWN AMOUNT OF MONEY AND RAN OUT THE FRONT DOOR. MRS. OTIS WAS LATER FOUND TO HAVE HAD \$1800 IN CASH IN HER HANDS AND IN A GREEN MONEY BAG.

AFTER THE ARRIVAL OF A SUPERVISOR AND DETECTIVES MRS. OTIS WAS TRANSPORTED TO THE SOUTH WEST SUBSTATION FOR FURTHER QUESTIONING. MRS. OTIS WAS THEN TRANSPORTED TO PCRJ AND CHARGED WITH AGGRAVATED ROBBERY, FELONY THEFT OF PROPERTY AND REFUSAL TO SUBMIT. MVR AND BWC IN USE.

**NARRATIVE**
