OFFICERS WERE DISPATCHED TO 12319 CHENAL PARKWAY (JERSEY MIKE'S SUBS) IN REFERENCE TO A ROBBERY OF A BUSINESS THAT HAD JUST OCCURRED. OFFICERS ARRIVED ON SCENE AND MADE CONTACT WITH THE CALLER, AYISHA FREEDMAN (MANAGER). FREEDMAN ADVISED THAT A BLACK MALE SUSPECT DRESSED IN ALL BLACK AND WEARING A MASK, ENTERED THE LOCATION THROUGH THE REAR EXIT ON THE WEST SIDE OF THE BUILDING. FREEDMAN STATED THE SUSPECT ENTERED THE LOCATION AND POINTED A BLACK HANDGUN AT A FFI I OW EMPLOYEE. JOSEPH JACKSON, FREEDMAN STATED THE SUSPECT FORCED JACKSON INTO THE MAIN LOBBY AREA WHERE SHE AND ANOTHER EMPLOYEE, JADA WRIGHT, WERE STATIONED. FREEDMAN ADVISED THAT THE SUSPECT TOLD WRIGHT AND JACKSON TO LAY ON THE GROUND WHILE POINTING THE HANDGUN AT ALL THREE VICTIMS. FREEDMAN ADVISED THE SUSPECT THEN DEMANDED FREEDMAN OPEN THE SAFE AND GIVE HIM ALL THE MONEY INSIDE IT. FREEDMAN STATED THAT SHE COMPLIED AND GAVE THE SUSPECT THE MONEY DUE TO THE THREAT OF IMMINENT FORCE. FREEDMAN ADVISED THE SUSPECT THEN DEMANDED FREEDMAN TO GET THE MONEY OUT OF THE CASH REGISTER. FREEDMAN ADVISED SHE TOLD THE SUSPECT THAT THERE WAS JUST CHANGE INSIDE THE REGISTER. FREEDMAN STATED THE SUSPECT STILL DEMANDED THE CHANGE AND FREEDMAN COMPLIED, GIVING THE SUSPECT THE CHANGE. FREEDMAN ADVISED THAT THE SUSPECT MADE HER PUT ALL OF THE MONEY STOLEN IN A BACKPACK. FREEDMAN ADVISED OFFICERS THE SUSPECT THEN TOLD THE VICTIMS TO STAY DOWN ON THE GROUND WHILE HE LEFT OUT OF THE REAR EXIT OF THE LOCATION AND HEADED WEST FROM THERE. FREEDMAN STATED THE MOMENT THE SUSPECT LEFT, SHE CALLED THE POLICE.

OFFICERS THEN MADE CONTACT WITH SUMMER MITCHELL (EMPLOYEE OF THE STORE NEXT DOOR). MITCHELL ADVISED THAT SHE WAS TAKING THE TRASH OUT TO THE DUMPSTER AND WAS FILMING HERSELF FOR SAFETY PURPOSES. NARRATIVE

OFFICERS RESPONDED TO 7206 INDIANA AVENUE FOR A BATTERY REPORT. OFFICERS MADE CONTACT WITH MS. ALECIA ALLEN. MS. ALLEN STATED THAT HER EX-BOYFRIEND, MR. CORDERO JACKSON, WAS AT THIS LOCATION AND ASSAULTED HER. HE THEN TOOK HER DOG AND HER PHONE.

MS. ALLEN STATED MR. JACKSON CAME OVER EARLIER THIS MORNING STATING HE HAD LEFT SOMETHING AT THIS RESIDENCE. HE CAME INTO CHECK AND STATED HE WANTED HER BULLIE DOG. SHE TOLD HIM HE COULD NOT HAVE IT AND LEFT UPSTAIRS. SHE HEARD TAMPERING WITH THE DOG AND CAME BACK INTO THE LIVING ROOM TO SEE MR. JACKSON TAKING THE DOG OUT OF ITS KENNEL. SHE ATTEMPTED TO STOP HIM AND HE BEGAN HITTING HER. SHE STATED HE THREW HER ON THE GROUND AND BEGAN TRYING TO TAKE THE DOG AGAIN. MS. ALLEN THEN ATTEMPTED TO GO TO THE KITCHEN TO GET A KNIFE TO PROTECT HERSELF FROM THE ATTACKS AND MR. JACKSON FOLLOWED HER AND BEGAN HITTING HER AGAIN. HE TOLD HER THAT HE WOULD KILL HER AND NOT TO UNDERESTIMATE HIM ABOUT THINGS. HE THEN GRABBED HER PHONE AND TOOK IT WITH HIM. HE TOLD HER SHE BETTER NOT CALL THE POLICE. HE WOULDN'T LET HER HAVE HER PHONE TO KEEP HER FROM CALLING THE

MS. ALLEN DID HAVE SOME SMALL SCRATCHES TO HER RIGHT HAND. SHE STATED SHE RECEIVED THE SCRATCHES WHEN MR. JACKSON WAS HITTING HER ON THE GROUND WHILE ATTEMPTING TO SHIELD HERSELF. MR. JACKSON LEFT THE AREA PRIOR TO OFFICERS' ARRIVAL DRIVING A DARK GRAY OR SILVER NISSAN KICK WITH BULLET HOLES AND PLASTIC IN THE BACK WINDOW. SHE STATED HE WAS POSSIBLY HEADED TO ELDORADO, ARKANSAS. MS. ALLEN ADVISED OFFICERS THAT MR. JACKSON WAS LIVING IN NORTH LITTLE ROCK. SHE ADVISED HE JUST GOT A JOB AT TABU IN LITTLE ROCK.
