### **NARRATIVE**

ON 02/13/2025, AT APPROXIMATELY 0750 HOURS, OFFICERS WERE DISPATCHED TO 315 N. BOWMAN ROAD #1 (LITTLE CAESARS PIZZA) FOR THE REPORT OF AN AGGRAVATED ROBBERY IN PROGRESS. THE REPORTING PARTY/VICTIM, DERRICK WARE, AN EMPLOYEE OF LITTLE CAESARS PIZZA, ADVISED DISPATCH THAT AN UNKNOWN SUSPECT ROBBED THE BUSINESS AND WAS ARMED WITH A HANDGUN.

I ARRIVED ON SCENE AND CONTACTED WARE, WHO PROVIDED THE FOLLOWING STATEMENT IN SUMMARY. ON 02/13/2025, AT APPROXIMATELY 0745 HOURS, WARE STATED THAT HE ARRIVED AT THE LITTLE CAESARS PIZZA TO OPEN THE BUSINESS. WARE STATED THAT AS HE WAS UNLOCKING THE FRONT DOOR AN UNKNOWN SUSPECT CAME FROM AROUND THE NORTH SIDE OF THE BUILDING.

WARE DESCRIBED THE SUSPECT AS A BLACK MALE ADULT, APPROXIMATELY 20-29 YEARS OLD, LIGHT SKIN COMPLEXION, AND SHORT. WARE STATED THAT THE SUSPECT WAS WEARING A WHITE JACKET WITH A RED AND BLUE STRIPE ON THE BOTTOM, AND BLACK PANTS. WARE ADVISED THE SUSPECT WAS WEARING A BURGUNDY FACE COVER AND WAS WEARING GLOVES.

WARE STATED THE SUSPECT APPROACHED HIM WITH HIS RIGHT HAND IN POCKET OF HIS JACKET. WARE STATED THAT HE COULD SEE THE SUSPECT WAS HOLDING A HANDGUN. WARE STATED THE SUSPECT TOLD HIM TO GO INSIDE. WHILE INSIDE OF THE BUSINESS THE SUSPECT TOLD HIM HE'S GETTING EVERYTHING OUT OF THE SAFE, AND INSTRUCTED HIM TO OPEN IT.

WARE STATED THAT HE OPENED UP THE SAFE, LOCATED UNDERNEATH THE FRONT COUNTER WHERE THE REGISTERS ARE LOCATED. WARE STATED THE SUSPECT REMOVED THE MONEY FROM THE BLUE DEPOSIT BAG INSIDE, AND EXITED OUT OF THE BACK OF THE BUSINESS. WARE ADVISED THE SUSPECT FLED SOUTHBOUND ON FOOT.

A CRIME SCENE WAS ESTABLISHED AND DETECTIVES RESPONDED TO SCENE. AN AGGRAVATED ROBBERY BROADCAST OF THE SUSPECT WAS MADE ON THE MAIN CHANNEL.

THE MANAGER OF THE LITTLE CAESARS PIZZA, SUMMAR STANDRIDGE (CONTACT #1), ARRIVED ON SCENE. STANDRIDGE STATED THE DEPOSIT BAG IN THE SAFE CONTAINED APPROXIMATELY \$800-\$1000. STANDRIDGE ADVISED THAT THE SECURITY CAMERAS INSIDE OF THE BUSINESS WERE OPERATIONAL. AS OF THE AUTHORING OF THIS REPORT, STANDRIDGE WAS NOT ABLE TO ACCESS THE SECURITY FOOTAGE. WARE AND STADRIDGE WERE PROVIDED THE INCIDENT NUMBER.

MVR AND BWC WERE IN USE.

## **NARRATIVE**

ON FEBRUARY 13, 2025, AT APPROXIMATELY 0635 HOURS, OFFICERS RESPONDED TO A ROBBERY AT 301 NORTH SHACKLEFORD, JASON'S DELI. OFFICERS ARRIVED QUICKLY AFTER THE CALL WAS DISPATCHED. ACCORDING TO COMMUNICATIONS, AN UNKNOWN SUSPECT IN ALL BLACK CLOTHING COMMITTED THE ROBBERY AND THEN FLED IN AN UNKNOWN DIRECTION.

ACCORDING TO LABELLE TYREE'S STATEMENT, 40 YO B/M DOB 5/5/1984, HE IS AN EMPLOYEE AT JASON'S DELI AND ARRIVED AT THE DELI AT APPROXIMATELY 0600 HOURS. HE RETRIEVED THE KEY FROM A LOCK BOX TO ENTER THE PREMISES. AFTER MAKING COFFEE INSIDE THE BUSINESS, HE SAW AN UNKNOWN BLACK MALE WEARING A BLACK HOODIE AND BLACK SHORTS UNDER BLACK PANTS NEAR THE FRONT OF THE STORE. MR. TYREE TOLD THE INDIVIDUAL THEY WERE CLOSED, THEN SHUT AND LOCKED THE DOOR. A WHILE LATER, NOT SEEING ANYONE OUTSIDE, HE EXITED TO RETURN THE KEY AND CHECKED BEHIND THE BUILDING. AT THAT TIME, THE SUSPECT APPEARED AGAIN, DISPLAYED A BLACK SEMI-AUTOMATIC HANDGUN WITH AN EXTENDED MAGAZINE, AND DEMANDED THAT MR. TYREE RETURN TO JASON'S DELI.

ACCORDING TO MR. TYREE, THE SUSPECT FOLLOWED HIM INSIDE THE DELI, DEMANDING MONEY. MR. TYREE STATED HE HAD NO MONEY, PROMPTING THE SUSPECT TO INQUIRE ABOUT A SAFE. NERVOUS, MR. TYREE BEGAN BACKING TOWARD A SECOND DOOR. THE SUSPECT ORDERED HIM TO STAY IN FRONT, THREATENING TO SHOOT IF MR. TYREE DID NOT COMPLY WITHIN FIVE SECONDS. WHEN MR. TYREE NOTICED THE SUSPECT LOCK THE FRONT DOOR, HE CLAIMED HE INTENDED TO LOCK THE SIDE DOOR AS WELL. UPON REACHING IT, HE UNLOCKED THE DOOR AND FLED THROUGH IT, LOSING HIS HAT AND PHONE WHILE ESCAPING. RUNNING NORTH THROUGH THE PARKING LOT, MR. TYREE SAW THE SUSPECT WAS NOT PURSUING HIM BUT APPEARED TO BE LEAVING. MR. TYREE REACHED THE WAFFLE HOUSE AND REQUESTED EMPLOYEES CALL THE POLICE ABOUT THE ROBBERY.

ACCORDING TO DEXTER BARKER'S STATEMENT, 53 YO B/M DOB 5/16/1971, HE WAS OBSERVED MOVING IN AND OUT OF JASON'S DELI UPON THE OFFICERS' ARRIVAL. MR. BARKER STATED HE DELIVERS PRODUCE TO THE STORE DAILY AND FOUND THE FRONT DOOR USUALLY UNLOCKED, SO HE CONTINUED WITH HIS DELIVERY WITHOUT SUSPICION.

OFFICERS BROADCASTED THE SUSPECT'S DESCRIPTION TO NEARBY UNITS. THE NORTHWEST SUPERVISOR, ROBBERY DETECTIVES, AND CRIME SCENE SEARCH UNIT WERE ALERTED AND RESPONDED. THE SCENE WAS PROCESSED FOR EVIDENCE, AND ALL INVOLVED PARTIES WERE INTERVIEWED.

OFFICERS OBSERVED WHAT APPEARED TO BE DAMAGE FROM A BULLET IN HIS FRONT PASSENGER SIDE WINDOW. OFFICERS OBSERVED SIMILAR DAMAGE TO THE REAR LEFT PASSENGER SIDE WINDOW. OFFICERS OBSERVED MR. CAAL TO HAVE CUTS ON HIS RIGHT ARM FROM BROKEN GLASS.

OFFICERS MADE CONTACT WITH DANIEL LUDUENA. MR. LUDUENA ADVISED HE WAS LETTING MR. CAAL OUT OF THE BUSINESS WHEN HE BEGAN TO HEAR GUN FIRE. MR. LUDUENA ADVISED HE HID UNTIL HE COULD NO LONGER HEAR GUNFIRE AND HE CALLED THE OWNER OF THE BUSINESS MIGUEL RAMIREZ.

OFFICERS MADE CONTACT WITH MIGUEL RAMIREZ. MR. RAMIREZ ADVISED HE WAS NOT IN THE BUILDING WHEN THE SHOOTING OCCURRED. HOWEVER, HIS WIFE, KATHY RAMIREZ, AND TWO CLIENTS, HUGO RODRIGO AND JHONNY ALEXANDER, WERE.

OFFICERS MADE CONTACT WITH THE PEOPLE WHO WERE INSIDE THE BUILDING WHEN THE SHOOTING OCCURRED. THEY ALL ADVISED THEY HAD NOT BEEN HIT AND HAD HID UNTIL FIRE HAD CEASED.

CRIME SCENE ARRIVED ON SCENE AND PROCESSED THE SCENE. MEMS ARRIVED AND MR. CAAL ADVISED HE DID NOT WANT TO BE TRANSPORTED. OFFICERS LEFT THE SCENE WITHOUT FURTHER INCIDENT.
