NARRATIVE

OFFICERS RESPONDED TO 11815 MARA LYNN ROAD FOR A ROBBERY OF A BUSINESS CALL. OFFICERS WERE ADVISED THIS LOCATION WAS JUST ROBBED AT GUN POINT. OFFICERS ARRIVED ON SCENE AND MADE CONTACT WITH MR. BRANDON RUNION, MANAGER. MR. RUNION STATED THERE WAS A BLACK MALE THAT JUST LEFT THIS LOCATION THAT DISPLAYED A GUN AND DEMANDED MONEY FROM THIS LOCATION. MR. RUNION WAS ABLE TO SHOW OFFICERS THE VIDEO OF THE INCIDENT. THERE WAS A BLACK MALE WEARING A LARGE RED HOODIE, BLACK PANTS, GLOVES, BLACK BOOTS, AND A BLACK MASK OVER HIS FACE APPROACHING THE LOCATION FROM THE NORTH BEHIND THE BUSINESS. AS HE APPROACHED MR. TONY WILLIAMSON WAS PREPARING FOR THE MORNING BRINGING THINGS FROM OUTSIDE IN HIS CAR TO THE INSIDE OF THE BUSINESS. THE BLACK MALE APPROACHED MR. WILLIAMSON, BUT MR. WILLIAMSON NOTICED A GUN IN HIS HAND SO HE THREW A LARGE PAN TO THE BLACK MALE. THEN WENT INSIDE AND LOCKED THE BACK DOOR. THE BLACK MALE WALKED AROUND THE STORE TO THE FRONT (SOUTH ENTRANCE). HE PUNCHED THE DOOR CODE TO UNLOCK THE DOOR AND GET INSIDE. ONCE INSIDE HE WENT TO THE BACK AND MADE CONTACT WITH BOTH MR. RUNION AND MR. WILLIAMSON AND DEMANDED MONEY. THE BLACK MALE COULD BE SEEN HOLDING A BLACK HANDGUN AND POINTING IT AT BOTH MR. RUNION AND MR. WILLIAMSON. THE TWO COOPERATED WITH THE BLACK MALE. MR. RUNION GAVE THE BLACK MALE THE MONEY FROM BOTH REGISTERS THE BLACK MALE LEFT OUT THE BACK OF THE BUSINESS AND TRAVELED NORTH ALONG THE WOODED AREA. HE CONTINUED UP THE HILL

OFFICERS CANVASSED THE AREA BUT COULD NOT LOCATE THE SUSPECT IN THE AREA. DETECTIVES WERE CALLED TO THE SCENE AND INTERVIEWED THE VICTIMS. SUPERVISORS WERE NOTIFIED AND RESPONDED TO THE INCIDENT.

NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION FOR A DISTURBANCE JUST OCCURED. CALL NOTES STATED A MALE, ARMED WITH A HANDGUN, HAD JUST LEFT AFTER CAUSING A DISTURBANCE.

WHEN OFFICERS ARRIVED ON SCENE THEY MADE CONTACT WITH MS. TURNER AND MS. TOWNSEND. MS. TURNER ADVISED MR. TOWNSEND IS THE FATHER OF HER CHILDREN AND HAD RECENTLY TRIED TO RESTART THEIR RELATIONSHIP. MS. TURNER ADVISED SHE WAS ASLEEP INSIDE OF THE LISTED LOCATION WHEN MR. TOWNSEND ARRIVED IN VEHICLE 1. SHE ADVISED HER DAUGHTER, MS. TOWNSEND, LET HIM IN AND HE WENT TO HER BEDROOM. SHE ADVISED MR. TOWNSEND THEN WOKE HER UP AND BEGAN QUESTIONING HER ABOUT ANOTHER MALE TALKING TO HER. SHE ADVISED MR. TOWNSEND THEN ADVISED HER "YOUR BREATH SMELLS LIKE DICK". SHE ADVISED SHE TOLD MR. TOWNSEND "IT ISN'T YOURS", WHICH MADE MR. TOWNSEND IRATE. SHE ADVISED MR. TOWNSEND THEN PULLED OUT A BLUE HANDGUN, WITH A SCOPE, OUT OF HIS PANTS. SHE ADVISED HE COCKED IT AND THEN BEGAN POINTING IT AT HER AND MS. TOWNSEND, WHO HAD COME INTO THE ROOM DUE TO THE COMMOTION.

WITH THE FIREARM NOW DRAWN AND POINTED AT MS. TOWNSEND AND MS. TURNER, MS. TURNER ADVISED MR. TOWNSEND BEGAN DEMANDING SHE OPEN HER PHONE FOR HIM AND GIVE IT TO HIM OR HE WOULD "PUT SIX IN HER (MS. TOWNSEND) AND FIVE IN YOU", REFERENCING SHOOTING BOTH VICTIMS. MS. TOWNSEND ADVISED A STRUGGLE THEN ENSUED OVER THE HANDGUN. MS. TURNER ADVISED SHE AND HER DAUGHTER WERE ABLE TO GET THE FIREARM AWAY FROM MR. TOWNSEND WHO THEN FLED THE RESIDENCE TO HIS VEHICLE.

MS. TURNER ADVISED MR. TOWNSEND THEN PULLED OUT A BLACK RIFLE OUT OF VEHICLE 1. MS. TURNER ADVISED SHE THEN THREW THE HANDGUN OUT THE FRONT DOOR AND THEN CLOSED AND LOCKED THE FRONT DOOR. SHE THEN BEGAN CALLING 911, USING MS. TOWNSEND'S PHONE AS SHE COULD NOT LOCATE HERS. WHILE CALLING 911, SHE ADVISED MR. TOWNSEND WOULD COLLECT THE HANDGUN AND FLEE IN VEHICLE 1.

MS. TOWNSEND STATEMENT WAS THE SAME AS MS. TURNER'S.

OFFICERS WOULD PROVIDE MS. TURNER AND MS. TOWNSEND WITH A LAURA'S CARD AND ADMINISTERED LETHALITY ASSESSMENTS. OFFICERS WOULD THEN MAKE A BROADCAST FOR MR. TOWNSEND AND VEHICLE 1.

MS. TOWNSEND WOULD ADVISE MR. TOWNSEND LIVED AT A RESIDENCE ON NORTH CHICOT ROAD BUT DID NOT KNOW THE NUMBER. OFFICERS RESPONDED TO THE AREA OF N. CHICOT ROAD AND WERE ABLE TO LOCATE VEHICLE 1 IN THE DRIVEWAY OF 7001 N. CHICOT ROAD. OFFICERS KNOCKED ON THE DOOR AND A FEMALE ANSWERED. OFFICERS ASKED IF MR. TOWNSEND WAS HOME AND THE FEMALE ADVISED HE WAS AND WENT TO GET HIM. WHEN MR. TOWNSEND CAME OUTSIDE TO OFFICERS, HE WAS TAKEN INTO CUSTODY.

MR. TOWNSEND IS AN AMPUTEE, MISSING HIS RIGHT LEG, AND REQUIRES CRUTCHES TO MOVE. DUE TO THIS, MR. TOWNSEND WAS NOT PLACED IN HANDCUFFS AND WAS JUST PLACED IN THE BACK SEAT OF A PATROL VEHICLE.

OFFICERS WOULD CONTACT MAJOR CRIMES DETECTIVES AND A SOUTHWEST SUPERVISOR. ALL PARTIES WOULD BE TRANSPORTED TO THE 12TH STREET DETECTIVES OFFICE FOR STATEMENTS. AT THIS TIME, MR. TOWNSEND WAS RAN FOR WARRANTS, WHICH REVEALED A FAILURE TO APPEAR WARRANT OUT OF LITTLE ROCK CRIMINAL COURT (LR-20-3610).
