UPON ARRIVAL, OFFICERS SPOKE WITH LAEVA COCHRUN WHO STATED SHE WAS PUTTING TWO JUVENILES IN THE VEHICLE WHEN SOMEONE BEGAN SHOOTING AT HER. COCHRUN STATED SHE DID NOT SEE WHO WAS SHOOTING AND IMMEDIATELY TOOK COVER. COCHMAN STATED THE JUVENILES WERE INSIDE THE VEHICLE WHILE THE SUSPECT WAS SHOOTING. OFFICERS NOTICED THE BACK RIGHT PASSENGER WINDOW WAS STRUCK AS WELL AS THE SAME DOOR. COCHMAN STATED THE JUVENILES WERE INSIDE OF THE VEHICLE AT THE TIME OF THE SHOOTING.

OFFICERS ALSO SPOKE WITH AUNDREA CLAYBORNE WHO WAS ALSO OUTSIDE WITH COCHRUN AT THE TIME OF THE SHOOTING. CLAYBORNE STATED SHE DID NOT SEE WHO WAS SHOOTING AND TOOK COVER IMMEDIATELY AS WELL.
