NARRATIVE

ON TUESDAY, FEBRUARY 26TH, 2025 AT APPROXIMATELY 2041 HOURS, OFFICERS RESPONDED TO A CHECK CONDITION OF A SUBJECT CALL FOR SERVICE IN THE AREA OF THE LISTED ADDRESS. UPON ARRIVAL, OFFICERS LOCATED JAMES FLOWERS JR. (W/M; 07/16/1986) SUFFERING FROM AN APPARENT GUNSHOT WOUND. MEMS AND RESCUE RESPONDED AND TRANSPORTED MR. FLOWERS JR. TO UAMS WHERE HE WAS PRONOUNCED DECEASED. WHILE CONDUCTING A PRELIMINARY INVESTIGATION, OFFICERS MADE CONTACT WITH RODRICK ALEXANDER JR. (B/M; 12/03/1992). MR. ALEXANDER JR. WAS DETAINED AND TRANSPORTED TO THE MAJOR CRIMES DIVISION FOR FURTHER INVESTIGATION. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. HOMICIDE DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR SURVEILLANCE FOOTAGE AND WITNESSES. DURING THE COURSE OF THE INVESTIGATION, MR. ALEXANDER JR. WAS DEVELOPED AS A SUSPECT IN THIS INCIDENT. MR. ALEXANDER WAS SUBSEQUENTLY RELEASED WITHOUT CHARGES PENDING A FILE REVIEW. THE PULASKI COUNTY CORONER RESPONDED TO UAMS AND TOOK POSSESSION OF MR. FLOWERS JR. FOR AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THE INVESTIGATION IS ON-GOING.
