NARRATIVE

ON FRIDAY, FEBRUARY 28TH, 2025 AT APPROXIMATELY 2314 HOURS, OFFICERS RESPONDED TO A SHOTS FIRED CALL FOR SERVICE IN THE AREA OF THE LISTED ADDRESS. UPON ARRIVAL, OFFICERS LOCATED EUGENE MCDANIEL (B/M; 11/06/1991) SUFFERING FROM AN APPARENT GUNSHOT WOUND. MEMS AND RESCUE RESPONDED, HOWEVER, MR. MCDANIEL WAS PRONOUNCED DECEASED ON SCENE. HOMICIDE DETECTIVES AND CSSU WERE NOTIFIED AND RESPONDED. HOMICIDE DETECTIVES BEGAN A PRELIMINARY INVESTIGATION AND CANVASSED THE AREA FOR WITNESSES AND SURVEILLANCE FOOTAGE. THE PULASKI COUNTY CORONER'S OFFICE RESPONDED AND TOOK POSSESSION OF MR. MCDANIEL FOR AN AUTOPSY. THE NEXT OF KIN WAS NOTIFIED. THE INVESTIGATION IS ON-GOING.
