NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN RELATION TO A THEFT CALL. OFFICERS MADE CONTACT WITH THE VICTIM, PRESTON ROE, WHO STATED THAT HE WAS DOWN BY THE TRAIN TRACKS TAKING PICTURES OF THE TRAINS WHEN THE SUSPECT, MATTHEW BIVENS PULLED OUT A SILVER KNIFE SAYING, "LEAVE OR I'M GOING TO STAB YOU!"
