#### **NARRATIVE**

ON 03/14/2025 OFFICERS RESPONDED TO THE LISTED LOCATION FOR A ROBBERY.

UPON ARRIVAL OFFICERS MADE CONTACT WITH AN EMPLOYEE, MR. FINLEY. MR. FINLEY ADVISED TWO BLACK MALES PUSHED SHOPPING CARTS FULL OF MERCHANDISE TO THE BACK OF THE STORE. AFTER EXITING THE BACK OF THE STORE MR. FINLEY ADVISED THE SUSPECTS GOT INTO A WHITE SEDAN WITH NO LPN WITH A BLACK FEMALE DRIVER AND LEFT THE SCENE GOING EAST BOUND ON 36TH STREET. MR. FINLEY ADVISED HE DID EVER OBSERVE A FIREARM DURING THE ALTERCATION.

OFFICERS NOTIFIED A SUPERVISOR AND MAJOR CRIMES DETECTIVES OF THE SITUATION.

OFFICERS BROADCASTED THE INFORMATION THEY WERE GIVEN. OFFICERS WERE ADVISED THE SUSPECTS DID NOT HAVE GLOVES ON WHEN THEY PUSHED THE BACK DOORS OPEN TO THE STORE. OFFICERS ATTEMPTED TO GATHER LATENT PRINTS OFF OF THE BACK EXIT DOOR WITH NEGATIVE RESULTS.

OFFICERS ADVISED THE EMPLOYEES TO DOWNLOAD THE SECURITY FOOTAGE AND CALL BACK WHEN THE FOOTAGE WAS COLLECTED. OFFICERS PROVIDED MR. FINLEY WITH AN INCIDENT NUMBER.

#### **NARRATIVE**

OCANA STATED SHE TRIED TO STOP THE VEHICLE FROM LEAVING SO THEY WOULD PAY THEIR TAB. OCANA STATED ALARCON TOLD HER TO MOVE OUT OF THE WAY ONCE THE VEHICLE STARTED FORWARD.
