NARRATIVE

OFFICERS RESPONDED TO A BATTERY CALL AT THE LISTED LOCATION AND IMMEDIATELY BEGAN CANVASSING THE AREA FOR THE SUSPECT, IDENTIFIED AS LADERRICK PRIDE, IN THE BATTERY AND A SHOOTING THAT OCCURRED AT THE LISTED LOCATION. COMMUNICATIONS ADVISED THE CALLER, STATED THE SUSPECT WAS LAST SEEN BEHIND BUILDING H. OFFICERS WERE UNABLE TO LOCATE THE SUSPECT. OFFICERS ADVISED COMMUNICATIONS THE SCENE WAS SECURE FOR MEDICAL. CONTACT WAS MADE WITH ONE OF THE VICTIMS. IDENTIFIED AS NINANA GREER. MS. GREER ADVISED THE SUSPECT FIRED SHOTS AT HER WHILE ON THE PREMISES. OFFICERS LOCATED MULTIPLE SHELL CASINGS IN THE AREA AS WELL AS A BULLET. MS. GREER ALSO STATED SHE IS PREGNANT, OFFICERS LOCATED TWO VICTIMS IN APARTMENT L21, IDENTIFIED AS ADORA AND LAILA ABERNATHY. MS. ADORA ABERNATHY ADVISED A BULLET WAS FIRED INTO HER APARTMENT, DAMAGING A WINDOW AND AN INTERIOR WALL, MS, ADORA AND LAILA ABERNATHY WERE NOT OBSERVED TO HAVE ANY PHYSICAL INJURY AND DID NOT REQUEST MEDICAL ATTENTION. THE VICTIMS OF THE TERRORISTIC ACT STATED THEY DIDN'T WISH TO PURSUE CHARGES AT THIS TIME. MS. GREER STATED A FRIEND OF HERS, IDENTIFIED AS MAKAYLA ROBINSON, WAS ALSO A VICTIM. MS. GREER STATED THE B/MS IN CUSTODY WERE NOT THE SUSPECT THAT SHOT AT HER. MAKAYLA ROBINSON WAS VERY IRATE AND REFUSED TO FULLY IDENTIFY HERSELF AND REFUSED TO COOPERATE IN PROVIDING SUSPECT INFORMATION. OFFICERS LEARNED MS. ROBINSON WAS STRUCK IN THE HEAD WITH A FIREARM BY THE SUSPECT. MEMS ARRIVED ON SCENE TO EVALUATE MS. ROBINSON, WHO DECLINED TO BE TRANSPORTED, MS. ROBINSON ADVISED OFFICERS SHE KNEW WHERE THE SUSPECT WAS LIKELY LOCATED AND POINTED OUT APARTMENT H13 IN BUILDING H, ALONG WITH SEVERAL SUBJECTS WHO WERE STANDING OUTSIDE THE DOOR, IDENTIFIED AS A JUVENILE MALE (JUV. 1), KOMIE HENDERSON JR., AND A SECOND JUVENILE MALE (JUV. 2.). AS OFFICERS APPROACHED THE SUBJECTS, MR. HENDERSON JR. RAN INSIDE THE APARTMENT AND SLAMMED THE DOOR CLOSED BEFORE OFFICERS COULD DETAIN HIM. MR. HENDERSON JR. THEN RAN OUT THE BACK DOOR OF THE APARTMENT AND BEGAN FLEEING ON FOOT WESTBOUND BEHIND BUILDING HAND THEN SOUTHBOUND ON AUXOR RD. WHILE PURSUING MR. HENDERSON JR. ON FOOT, OFFICERS OBSERVED A FIREARM IN HIS HAND, MR. HENDERSON JR. THREW THE FIREARM WHILE OFFICERS PURSUED. OFFICERS DID RECOVER THE FIREARM. OFFICERS WERE ABLE TO APPREHEND MR. HENDERSON JR. AND PLACED HIM IN HANDCUFFS. WHICH WERE DOUBLE-LOCKED AND CHECKED FOR TIGHTNESS, AND ESCORTED HIM TO A PATROL VEHICLE WHERE A SEARCH OF HIS PERSON WAS CONDUCTED, WITH NEGATIVE RESULTS. MR. HENDERSON JR. WAS THEN PLACED IN THE BACK SEAT OF THE PATROL VEHICLE. ALSO WHILE APPROACHING THE SUBJECTS AT APARTMENT H13, THE TWO JUVENILE MALES WERE DETAINED AND PLACED IN HANDCUFFS, WHICH WERE DOUBLE-LOCKED AND CHECKED FOR TIGHTNESS. AFTER BEING ESCORTED TO A PATROL CAR, A SEARCH OF JUV. 1'S PERSON WAS CONDUCTED, WHICH YIELDED A FIREARM TUCKED IN HIS UNDERWEAR. THE FIREARM WAS SECURED AND JUV. 1 WAS PLACED IN THE PATROL VEHICLE, JUV. 2 WAS ESCORTED TO A DIFFERENT PATROL VEHICLE AND A SEARCH OF HIS PERSON WAS CONDUCTED AS WELL, WHICH YIELDED NEGATIVE RESULTS. JUV. 2 WAS THEN PLACED IN THE BACK SEAT OF THE PATROL VEHICLE, BUT WAS LATER RELEASED TO HIS MOTHER, IDENTIFIED KISHA SANDERS, AS AFTER HE WAS DETERMINED TO HAVE NO APPARENT ROLE IN THE INCIDENT. MR. HENDERSON JR. WAS TRANSPORTED TO PCRJ WHERE HE WAS CHARGED WITH OBSTRUCTING GOVERNMENTAL OPERATIONS FOR REFUSING TO IDENTIFY HIMSELF AND FLEEING. JUV. 1 WAS FIRST TRANSPORTED TO THE SOUTHWEST SUBSTATION AND OFFICERS CONTACTED JUVENILE INTAKE AND SPOKE TO INTAKE OFFICER ROSS WHO ADVISED TO TRANSPORT JUV. 1 TO THE DETENTION CENTER. INTAKE OFFICER CONTACTED JUV. 1'S MOTHER AND ADVISED HER OF THE CIRCUMSTANCES. THE FIREARMS, SHELL CASINGS, AND BULLETS WERE ALL STORED AT THE SOUTHWEST SUBSTATION AS EVIDENCE. OFFICERS TRANSPORTED JUV. 1 TO THE DETENTION CENTER, CHARGING HIM WITH POSSESSION OF A HANDGUN BY A MINOR AND OBSTRUCTING GOVERNMENTAL OPERATIONS FOR REFUSING TO ALLOW OFFICERS TO CONTINUE ADDRESSING THE INCIDENT BY KICKING THE PATROL VEHICLE'S DOORS YELLING, UNBUCKLING HIS SEATBELT, AND STANDING UP IN THE BACK SEAT OF THE PATROL VEHICLE WHILE IN TRANSPORT AS OFFICERS WERE WORKING WITH JUVENILE INTAKE TO DETERMINE A COURSE OF ACTION. NO FURTHER POLICE ACTION WAS TAKEN. MVR/BWC IN USE.

NARRATIVE

OFFICERS ARRIVED ON SCENE IN RESPONSE TO A SHOTS FIRED CALL AT 7424 DAHLIA DR. UPON ARRIVAL. VICTIMS WERE STANDING OUTSIDE OF THEIR HOME. OFFICERS SPOKE WITH MS. NIKKI YOUNG WHO STATED SHE WAS SLEEPING UPSTAIRS WHEN THE SHOOTING INCIDENT OCCURRED. MS. YOUNG STATED THAT HER DAUGHTER, MS. ANTIONETTE WILLIAMS, WAS SLEEPING INSIDE OF THE VEHICLE ON THE DRIVER SIDE WHEN SHOTS WERE FIRED. MS. YOUNG STATED THE SHOTS HIT HER VEHICLE AS WELL AS HER HOME SEVERAL TIMES AND SHOWED OFFICERS AREAS OF DAMAGE. SHOTS WERE FIRED AT THE TRUNK OF THE VEHICLE AS WELL AS THE SIDE BY THE GAS TANK. MS. PATRICIA SMITH (MS. YOUNG DAUGHTER) STATED THAT SHE HEARD APPROXIMATELY 30 SHOTS BEING FIRED. MS. YOUNG STATED THAT HER NEIGHBOR WOULD POSSIBLY HAVE FOOTAGE WITH MORE DETAILS. SHELL CASINGS WERE PRESENT AS WELL AS GLASS IN THE MIDDLE OF THE STREET IN FRONT OF THE VICTIMS HOME. MS. SMITH STATED THAT THERE WAS NO GLASS IN THE MIDDLE OF THE STREET BEFORE THE SHOOTING INCIDENT. MS. YOUNG STATED THERE WERE 7 PEOPLE INSIDE OF HER HOME AT THE TIME OF THE SHOOTING INCIDENT INCLUDING TWO OF HER GRANDBABIES. MS. YOUNG STATED HER DAUGHTERS BOYFRIEND, WHO IS UNKNOWN AT THIS TIME, RECENTLY HAD COURT IN REFERENCE TO A HOMICIDE. YOUNG SAID THE VICTIMS FAMILY CAUSED A DISTURBANCE AT COURT AND BELIEVES THE VICTIMS FAMILY IS RETALIATING BY SHOOTING AT HER HOUSE. GUY JOHNSON SAID HE WITNESSED THE GUN SHOTS AND CHECKED HIS VIDEO FOOTAGE. HE SAID IT SHOWED TWO DARK VEHICLES DRIVING BY. CRIME SCENE BARRIER TAPE WAS IN USE TO SECURE THE SCENE. A CRIME SCENE LOG WAS STARTED. SERGENT MONROE WAS NOTIFIED. MAJOR CRIME DETECTIVE ALONG WITH CRIME SCENE UNIT WERE NOTIFIED AND RESPONDED ON SCENE. MVR AND BWC **ACTIVATED**
