NARRATIVE

OFFICERS RESPONDED TO A TERRORISTIC ACT AT THE LISTED ADDRESS. OFFICERS MADE CONTACT WITH ONE OF THE CALLERS, MS. PICKERING.

MS. PICKERING STATED SHE WAS RELAXING AT THE LISTED ADDRESS, OWNED BY HER BOYFRIEND, MR. CROSBY, AT APPROXIMATELY 1230 HOURS. MS. PICKERING STATED SHE HEARD A B/F, LATER IDENTIFIED AS MS. STEVENSON, YELLING AT HER TO COME OUTSIDE, BANGING ON THE DOOR, USING OBSCENETIES, AND THREATENING TO "SETTLE THINGS." MS. PICKERING STATED SHE NEVER MADE CONTACT WITH MS. STEVENSON. MS. PICKERING STATED SHE ATTEMPTED TO CALL 911 BUT WAS DISREGARDED BY THE OPERATOR. MS. PICKERING STATED SHE CALLED MR. CROSBY WHO CAME AT APPROXIMATELY 1245 HOURS AND PICKED HER UP BEFORE DRIVING TO 615 WEST MARKHAM.

OFFICERS MADE CONTACT WITH MR. CROSBY WHO ADVISED HE RECENTLY BROKE UP WITH MS. STEVENSON. MR. CROSBY STATED MS. STEVENSON HAD SENT THREATS EARLIER THAT MORNING ON FACEBOOK MESSENGER, BUT HAD DELETED THE MESSAGES PRIOR TO THE TERRORISTIC ACT. MR. CROSBY STATED HE ANSWERED A PHONECALL FROM MS. STEVENSON WHILE HE AND MS. PICKERING WERE ON THE WAY TO 615 WEST MARKHAM. MR. CROSBY STATED MS. STEVENSON CUSSED HIM OUT ABOUT "HAVING ANOTHER WOMAN" AND HEARD THREE GUNSHOTS AND GLASS BREAKING. MS. PICKERING ADVISED OF THE SAME.

OFFICERS OBSERVED THREE ENTRANCE HOLES INTO THE APARTMENT, THAT DID NOT CONTINUE INTO THE ADJACENT APARTMENT.

OFFICERS MADE CONTACT WITH A NEIGHBOR WHO WISHED TO STAY ANONYMOUS, BUT SENT OFFICERS A VIDEO OF MS. STEVENSON DRIVING AWAY SHORTLY AFTER THE TERRORISTIC ACT IN HER SILVER NISSAN SENTRA (LPN: BDV18V).

WHILE OFFICERS WERE ON SCENE, MS. STEVENSON CALLED MR. CROSBY, WHO ANSWERED ON SPEAKER. MR. CROSBY ASKED MS. STEVENSON WHY SHE SHOT HIS APARTMENT TO WHICH SHE REPLIED "BECAUSE YOU'RE WITH THAT FEMALE." OFFICERS COMPLETED A LETHALITY FORM AND ISSUED MR. CROSBY A LAURA'S CARD.

OFFICERS NOTIFIED SGT. MCNUTT, WHO RESPONDED. MAJOR CRIMES AND SGT. THOMAS WAS NOTIFIED. OFFICERS MADE A BROADCAST FOR MS. STEVENSON AND HER NISSAN. OFFICER SNOW MADE A TRAFFIC STOP ON VEH1 AT I-630 AND I-430 (INCIDENT #2025-034264). OFFICER SNOW IDENTIFIED THE DRIVER, MR. SCOTT, SEARCHED THE VEHICLE FOR FIREARMS, WITH NEGATIVE RESULTS, AND RELEASED MR. SCOTT AND VEH1. PRIOR TO MR. SCOTT'S RELEASE, HE ADVISED OFFICER SNOW HE DROPPED OFF MS. STEVENSON AT "AN APARTMENT COMPLEX ON CANTRELL" BUT WOULD NOT GO INTO FURTHER ON WHERE.

OFFICERS WENT BACK TO 6838 CANTRELL ROAD AND CIRCULATED THE AREA FOR MS. STEVENSON WITH NEGATIVE RESULTS. OFFICERS ADVISED MR. CROSBY AND MS.PICKERING TO CALL BACK IF MS. STEVENSON WAS ON SCENE.
