NARVESON THEN GOT BACK INTO THE U-HAUL VAN AND FLED THE SCENE. MR. DODSON-IRWIN ADVISED MS. NARVESON IS AN ACQUAINTANCE HE KNOWS THROUGH A MUTUAL FRIEND. MR. DODSON-IRWIN ADVISED MS. NARVESON WAS MAD AT HIM DUE TO HIM TELLING SOMEONE ELSE ABOUT HER BREAKING INTO STORAGE UNITS AND STILLING SEVERAL FIREARMS.

OFFICERS ADVISED MR. DODSON-IRWIN A DETECTIVE WOULD BE MAKING CONTACT WITH HIM IN REFERENCE TO THIS INCIDENT. MR. DODSON-IRWIN ADVISED HE DID NOT HAVE A PHONE BUT PROVIDED HIS MOTHER'S PHONE NUMBER AS A POINT OF CONTACT.
