NARRATIVE

ON APRIL 13, 2025, I RESPONDED TO 11201 BASS PRO PARKWAY FOR REPORT OF A ROBBERY. UPON ARRIVAL, I MADE CONTACT WITH MCINTIRE. MCINTIRE ADVISED HE WAS CONTACTED ON FACEBOOK MESSENGER BY A SUBJECT NAMED TRE' WHO WAS INTERESTED IN BUYING FIVE PAIRS OF SHOES WHICH MCINTIRE HAD FOR SALE. MCINTIRE AGREED TO MEET TRE' AT THE AFOREMENTIONED LOCATION AROUND 1430 HOURS.

MCINTIRE ADVISED TRE' ARRIVED AS THE PASSENGER IN A RED HYUNDAI HATCHBACK CAR. TRE' WALKED TO THE PASSENGER SIDE OF MCINTIRE'S VEHICLE, TALKED ABOUT THE SHOES FOR A MOMENT, AND GOT IN HIS VEHICLE. MCINTIRE ADVISED HE AND TRE' AGREED TRE' WOULD PAY HIM \$1000 FOR ALL OF THE SHOES. MCINTIRE ADVISED HE REACHED MONEY OUT OF HIS OWN POCKET, FOR AN UNKNOWN REASON, AND TRE' TOOK THE MONEY FROM HIM. TRE' THEN DISPLAYED A BLACK HAND GUN WITH AN EXTENDED MAGAZINE IN HIS WAISTBAND, LOOKED AT MCINTIRE, AND STATED ALL OF THIS IS MINE NOW.

TRE' TOOK MCINTIRES PHONE AND DELETED THE PHONE CONVERSATION THE TWO OF THEM HAD AND THREW HIS PHONE UNDER THE PASSENGER SEAT. TRE' THEN TOOK THE MONEY AND SHOES AND LEFT IN THE RED HYUNDAI.

MCINTIRE ADVISED THE DRIVER OF THE RED HYUNDAI WAS A BLACK MALE BUT THAT IS ALL OF THE DESCRIPTION HE COULD PROVIDE.

PER SERGEANT ONCKEN, I CONTACTED 3-11 DETECTIVES TO REQUEST FOR THE CRIME SCENE SEARCH UNIT TO RESPOND TO PROCESS THE CRIME SCENE. DETECTIVE MADISON ADVISED ME SERGENT H. THOMAS INFORMED HIM THE CRIME SCENE SEARCH UNIT WOULD NOT RESPOND AND I NEEDED TO PROCESS THE SCENE MYSELF.

I DUSTED THE VICTIMS PHONE FOR FINGERPRINTS. I WAS ABLE TO LIFT PRINTS OFF OF THE FRONT AND THE BACK OF THE PHONE. I DUSTED THE INSIDE OF THE VICTIMS VEHICLE FOR PRINTS AS WELL WITH NEGATIVE RESULTS. I STORED THE LATENT PRINTS UNDER THIS INCIDENT NUMBER AT THE SOUTHWEST SUBSTATION.

I ASKED MCINTIRE IF HE WAS ABLE TO RELOCATE TRE'S FACEBOOK PROFILE AFTER THE INCIDENT AND HE SAID HE WAS UNABLE.
