NARRATIVE

OFFICERS WERE DISPATCHED TO A SHOOTING IN PROGRESS AT THE SUPER GALLERIA GAS STATION. UPON ARRIVAL THE LOCATED WATTS AND PHILLIPS IN THE 3300 BLOCK OF MARY SUFFERING FROM APPARENT GUNSHOT WOUNDS. MEMS RESPONDED AND DETERMINED WATTS HAD SUCCUMBED TO HIS INJURIES ON SCENE. PHILLIPS WAS TRANSPORTED TO UAMS WHERE HE WAS TAKEN INTO SURGERY AND IS CURRENTLY LISTED AS CRITICAL BUT STABLE. DURING THE ON SCENE INVESTIGATION DETECTIVES WERE NOTIFIED ANOTHER VICTIM, KELLEY, HAD ARRIVED AT UAMS BY PRIVATE VEHICLE AND STATED IT WAS DURING THIS INCIDENT. THE PULASKI COUNTY CORONER RESPONDED AND TOOK POSSESSION OF WATTS' BODY FOR SUBMISSION TO THE MEDICAL EXAMINER. THE INVESTIGATION IS ONGOING.
