**NARRATIVE**

PHILLIPS ADVISED THE SUBJECT ATTEMPTED TO STEAL THE LISTED ITEM AND LEAVE OUT THE EMERGENCY EXIT LOCATED AT THE BACK OF THE STORE. MR. PHILLIPS STATED THE ALARM SOUNDED AND THERE WAS A DELAY AND THE SUBJECT WAS UNABLE TO EXIT. MR. PHILLIPS ADVISED THE SUBJECT THEN ATTEMPTED TO EXIT THROUGH THE FRONT DOOR WITH ITEM BUT WAS STOPPED BY HIM AND MR. CLARK. MR. HER FRIEND IN THIS BUILDING IS THE ONE WHO CALLED FOR OFFICERS. A RESIDENT IN THE AREA ADVISED US THAT HE HUNG OUT WITH A FEMALE AT 1101 COLLEGE ST. SANDERS WAS TRANSPORTED TO THE HOSPITAL FOR TREATMENT BY MEMS. SHE WAS ALSO PROVIDED AN INCIDENT CARD AND ADVISED A DETECTIVE WOULD BE CONTACTING HER AT A LATER DATE TO FOLLOW UP. OFFICERS THEN LEFT THE LOCATION AND RESPONDED TO 1101 COLLEGE ST IN AN ATTEMPT TO FIND SMITH WITH NEGATIVE RESULTS.
