NARRATIVE

OFFICERS RESPONDED TO 7710 COLONEL GLENN ROAD (DOLLAR GENERAL) IN REFERENCE TO A ROBBERY OF AN INDIVIDUAL INCIDENT. CONTACT WAS MADE WITH ANGELA BAKER WHO ADVISED THREE AFRICAN AMERICAN TEENS APPROACHED HER WHILE SHE WAS INSIDE HER VEHICLE. MS. BAKER ADVISED ONE OF THE TEENS BRANDISHED A SILVER OVER BLACK HANDGUN, POINTED IT AT HER AND DEMANDED HER VEHICLE. DOLLAR GENERAL EMPLOYEES SHOWED VIDEO FOOTAGE OF THE INCIDENT. WHILE IN ROUTE TO THIS INCIDENT, AT 8700 COLONEL GLENN ROAD, EDWIN VASQUEZ ADVISED JUVENILES OF THE SAME DESCRIPTION ATTEMPTED TO TAKE HIS VEHICLE AS WELL. MR. VASQUEZ ADVISED ONE OF THE JUVENILES SHOWED A FIREARM IN HIS WAISTBAND AND DEMANDED HIS VEHICLE. MR. VASQUEZ ADVISED HE REACHED INSIDE A BAG OF HIS AS IF HE HAD A FIREARM AND THE JUVENILES FLED EASTBOUND ON COLONEL GLENN ROAD.

WHILE IN ROUTE TO THE INCIDENT, VIA FLOCK, THE REAL-TIME CRIME CENTER ADVISED THE VEHICLE WAS OBSERVED IN THE AREA OF MABELVALE PIKE AND FAIR PARK BLVD. OFFICERS CIRCULATED THE AREA AND LOCATED THE VEHICLE NEAR THE 2900 BLOCK OF BOULEVARD STREET. A BRIEF VEHICLE PURSUIT ENSUED EASTWARD ON BOULEVARD STREET AND ENDED AT THE 2800 BLOCK OF ABIGAIL STREET WHERE THE VEHICLE COLLIDED WITH AND RESTED ON A WIRE-MESH FENCE. THREE SUSPECTS EXITED THE VEHICLE AND FLED ON FOOT. DUE TO THE VIOLENT OFFENSE OFFICERS GAVE CHASE ON FOOT AND APPREHENDED ALL SUSPECTS. JUVENILE 1 REFUSED TO STOP AND WAS TASED. ALL THREE JUVENILES WERE DETAINED AND TRANSPORTED TO THE 12TH STREET SUBSTATION. A SEARCH OF VEHICLE 1 YIELDED A SILVER OVER BLACK FIREARM LOCATED IN THE BACK SEAT AREA. JUVENILE 3 WAS IN POSSESSION OF A GREEN LEAFY SUBSTANCE.

AFTER BRIEF INTERVIEWS, JUVENILE 1 WAS CHARGED AS AN ADULT AND TRANSPORTED TO THE PULASKI COUNTY REGIONAL JAIL WITH THE LISTED CHARGES: TWO (2) COUNTS AGGRAVATED ROBBERY, THEFT OF PROPERTY, MINOR IN POSSESSION OF A FIREARM, CRIMINAL MISCHIEF, AND FELONY AND MISDEMEANOR FLEEING. JUVENILE 3 WAS CHARGED AS AN ADULT AND TRANSPORTED TO THE PULASKI COUNTY REGIONAL JAIL WITH THE LISTED CHARGES: TWO (2) COUNTS AGGRAVATED ROBBERY, THEFT OF PROPERTY, FLEEING ON FOOT AND MISDEMEANOR POSSESSION OF A CONTROLLED SUBSTANCE. JUVENILE 2 WAS CHARGED AS A JUVENILE AND TRANSPORTED TO PULASKI COUNTY JUVENILE DETENTION WITH THE LISTED CHARGES: TWO (2) COUNTS AGGRAVATED ROBBERY, THEFT OF PROPERTY, AND FLEEING ON FOOT. JUVENILE 2 COMPLAINED OF BREATHING ISSUES AND WAS TRANSPORTED TO ACH, TREATED, AND RETURNED TO THE 12 STREET SUBSTATION PRIOR TO GOING THE JUVENILE DETENTION. LT. BEWLEY WAS ON SCENE. MAJOR CRIMES DETECTIVES AND CSSU RESPONDED. VEHICLE 1 WAS RECOVERED. SERGEANT WALTON WAS NOTIFIED.
