**NARRATIVE**

THE COUPLE ADVISED THEY WERE HOME WHEN THE INCIDENT TOOK PLACE.

OFFICERS NOTIFIED A 12TH STREET PATROL DIVISION SUPERVISOR AND NOTIFIED MAJOR CRIMES. OFFICERS THEN SECURED A CRIME SCENE AND WAITED TO PROCESS THE SCENE UNTIL MAJOR CRIMES ARRIVED. OFFICERS STORED THE EVIDENCE AT THE 12TH STREET SUBSTATION PROPERTY ROOM IN ACCORDANCE WITH DEPARTMENTAL POLICY. MVR AND BWC IN USE.
