**NARRATIVE**

OFFICERS RESPONDED TO 3003 WEST MARKHAM STREET FOR REPORT OF A BATTERY WHICH HAD JUST OCCURRED. UPON ARRIVAL, OFFICERS SPOKE TO ALLEN WHO STATED WELCH HAD ASSAULTED HIM WITH A WEAPON.

ALLEN ADVISED HE WAS STANDING IN FRONT OF 1503 BOOKER STREET SMOKING TOBACCO WHEN WELCH APPROACHED HIM AND DEMANDED THE \$37 DOLLARS HE OWES HER. ALLEN STATED HE DOES IN FACT OWE ALLEN MONEY BUT DID NOT HAVE THE MONEY. WHEN ALLEN EXPLAINED THIS TO WELCH, SHE PRODUCED A BLACK HANDLED KNIFE AND PRESSED IT AGAINST HIS THROAT AND THEN AGAINST HIS SIDE. ALLEN STATED WELCH TRIED TO KILL HIM.

OFFICERS DID NOT OBSERVE ANY INJURY TO ALLEN AND HE CONFIRMED HE WAS NOT INJURED. ALLEN STATED HE RAN AWAY FROM WELCH AND STOPPED AT THIS LOCATION TO CALL THE POLICE BECAUSE HIS PHONE WAS ABOUT TO DIE.

ALLEN STATED WELCH LIVES NEAR WEST 19TH STREET AND BOOKER STREET BUT HE DOES NOT KNOW HER ADDRESS. OFFICERS CIRCULATED THE AREA FOR WELCH WITH NEGATIVE RESULTS. MVR AND WBC IN USE 23C769.

**NARRATIVE**

OFFICERS RESPONDED TO A BATTERY CALL AT THE LISTED LOCATION.

UPON ARRIVAL, OFFICERS MADE CONTACT WITH AN I/M IDENTIFIED AS MR. KAVAN KUMAR. MR. KUMAR ADVISED OFFICERS THAT AN UNIDENTIFIED B/M HAD ENTERED THE BUSINESS AND DEMANDED TICKETS FROM HIM. MR. KUMAR STATED THAT HE HAD DENIED THE SALE TO THE SUSPECT. THE SUSPECT HAD THEN ENGAGED IN A VERBAL ALTERCATION, HE ADVISED. MR. KUMAR ADVISED THAT THE SUSPECT HAD THEN COME BEHIND THE COUNTER, DEMANDED CIGARETTES BEFORE HITTING HIM WITH HIS FIST AND TAKING A BOX OF CIGARETTES. THE SUSPECT HAD THEN PROCEEDED TO THE COOLERS AND TAKEN ONE BEER BOTTLE, MR. KUMAR STATED. THE SUSPECT HAD THEN LEFT NORTHBOUND ON FOOT PRIOR TO OFFICERS ARRIVAL, MR. KUMAR ADVISED. THE SUSPECT HAD SAID THAT HE WAS THE OWNER OF THE BUSINESS, MR. KUMAR STATED.

MR. KUMAR SHOWED PHYSICAL INJURY IN THE FORM OF BRUISING TO THE INSIDE OF HIS LEFT ELBOW. MR. KUMAR DECLINED EMERGENCY MEDICAL ATTENTION AT THIS TIME.
