**NARRATIVE**

OFFICERS RESPONDED TO A ROBBERY OF AN INDIVIDUAL AT THE LISTED ADDRESS. OFFICERS MADE CONTACT WITH JUAN DUENAS, WHO STATED THAT HE WAS SLEEPING OUTSIDE IN HIS VEHICLE WITH THE WINDOWS DOWN AND BOTH THE DRIVER AND PASSENGER SIDE DOORS OPEN. ACCORDING TO JUAN DUENAS, AN UNKNOWN BLACK MALE BETWEEN THE AGES OF 18 AND 20 APPROACHED HIS VEHICLE, STRUCK HIM IN THE HEAD WITH AN OPEN HAND, AND TOOK HIS BLACK GALAXY S21 FROM THE DRIVER'S SIDE DOOR WHERE IT HAD BEEN PLACED.

JUAN DUENAS STATED THAT HE COULD ONLY DESCRIBE THE SUSPECT AS A BLACK MALE WEARING A BLUE SHIRT WITH A FADE HAIRCUT. JUAN DUENAS STATED THAT THE SUSPECT FLED ON FOOT NORTHBOUND ON FOSTER STREET TOWARD W. 36TH STREET. JUAN DUENAS STATED THAT THE ONLY ITEM TAKEN WAS HIS PHONE.

OFFICERS OBSERVED JUAN DUENAS WITH A RED, BLOODY KNOT ON HIS LEFT TEMPLE AND BLOOD ON HIS FACIAL CHEEK. OFFICERS ISSUED THIS INCIDENT NUMBER AND GAVE A CITYWIDE BOLO BROADCAST. OFFICERS CANVASSED THE AREA BUT DID NOT LOCATE THE SUSPECT. JUAN DUENAS DECLINED MEDICAL TREATMENT AND COULD NOT PROVIDE ANY FURTHER DETAILED INFORMATION ABOUT THE SUSPECT. NO FURTHER POLICE ACTION WAS NEEDED. BWC WAS IN USE.
