**NARRATIVE**

OFFICERS WERE DISPATCHED TO THE LISTED LOCATION REGARDING UNKNOWN TROUBLE. UPON ARRIVAL OFFICES MADE CONTACT WITH JENNIFER ESTER, WHO STATED " THEY" AMBUSHED HER AND ROBBED HER OF \$8.00. ESTER DID KNOW WHO IT WAS AND CONTINUED TO REFER TO THE SUBJECTS AS "THEY". ESTER THEN STATED SHE WANTED TO RETRIEVE HER BELONGINGS FROM HER RESIDENCE WHERE OFFICERS OFFERED TO HELP HER, BUT SHE THEN STATED SHE WOULD HAVE SOMEONE ELSE TO GET HER BELONGINGS. DURING OFFICERS INTERACTION WITH ESTER, IT WAS APPARENT ESTER HAD MENTAL HEALTH ISSUES DUE TO HER BEHAVIOR. ESTER DECLINED MEDICAL ATTENTION AND ASKED OFFICERS FOR A RIDE TO 8818 KANIS. OFFICERS TRANSPORTED ESTER TO 8818 KANIS WITHOUT INCIDENT. MVR AND BWC USED.

**NARRATIVE**

WE RESPONDED TO THE LOCATION PER REQUEST OF HUSSAIN WHO ADVISED A WHITE FEMALE CAME INTO THE STORE, DEMANDED MONEY, AND THEN THREW SHARDS OF GLASS AT HIM. THE SUSPECT WAS DESCRIBED AS A WHITE FEMALE WITH A BLUE SHIRT AND BLUE SHORTS. WHEN WE ARRIVED ON SCENE, I IMMEDIATELY OBSERVED A PERSON MATCHING THE DESCRIPTION SITTING ON THE SIDEWALK IN FRONT OF THE STORE. AS I EXITED MY VEHICLE THE FEMALE STOOD UP AND STARTED TO APPROACH ME, TURNED AROUND, AND PLACED HER HANDS BEHIND HER BACK. WHEN I ASKED WHY SHE WAS DOING THAT SHE STATED THAT SHE WANTED MONEY AND SHE WAS TRYING TO ROB THE STORE. SHE WAS PLACED INTO CUSTODY AND THE HANDCUFFS WERE DOUBLE LOCKED AND CHECKED FOR TIGHTNESS. I SPOKE TO THE CLERK (HUSSAIN) HE SAID THE WOMAN WALKED INTO THE STORE AND DEMANDED MONEY. WHEN HE REFUSED TO GIVE HER MONEY SHE THREW A LARGE PIECE OF A GLASS MIRROR AT THE CLERK WINDOW WHICH SHATTERED AND SENT SMALL SHARDS OF GLASS INTO THE CLERKS AREA BEHIND THE COUNTER. SHE THEN STARTED THROWING ITEMS OFF OF THE SHELVES AND KNOCKING OVER STANDS WITH GOOD ON THEM CAUSING SIGNIFICANT DAMAGE TO THE ITEMS. SHE ALSO RIPPED THE CREDIT CARD READER OFF THE COUNTER AND PULLED OUT WIRES GOING TO THE CAMERA SYSTEM. SHE DID NOT GET ANY MONEY FROM THE STORE. SHE WENT OUTSIDE AND WAITED FOR POLICE. HUSSAIN DID NOT HAVE ANY VISIBLE INJURIES BUT COMPLAINED THAT HIS LEFT EYE WAS IRRITATED AND BELIEVES HE MAY HAVE A SMALL PIECE OF GLASS IN IT. MEMS RESPONDED TO CHECK ON HIM BUT HE REFUSED TO BE TRANSPORTED. 1L32 WAS NOTIFIED ALONG WITH ROBBERY DETECTIVES WHO RESPONDED TO THE SCENE. THE SUSPECT WAS IDENTIFIED AS FUGITT. SHE WAS TRANSPORTED TO THE DETECTIVES OFFICE WHERE SHE WAS CHARGED WITH ROBBERY AND CRIMINAL MISCHIEF. SHE WAS TRANSPORTED TO PCRJ AND BOOKED IN ON AN ADR. THE DEPUTIES AT PCRJ TOOK ANY PROPERTY SHE HAD ON HER. FUGITT WAS ADVISED THAT SHE IS BANNED FROM THE LOCATION. MVR AND BWC WERE IN USE.

## NARRATIVE

OFFICERS RESPONDED TO 6828 COLONEL GLENN RD FOR AN AGGRAVATED ROBBERY OF AN INDIVIDUAL. THIS INCIDENT OCCURRED AT 3510 S BRYANT ST (PARKWOOD APARTMENTS). UPON ARRIVAL, OFFICERS MADE CONTACT WITH THE COMPLAINANT (THOMAS SMITH).

THE UNKNOWN SUBJECT THEN TOOK OFF RUNNING WITH THE ITEMS, LAST SEEN GOING NORTHBOUND ON S BRYANT STREET. MR. SMITH WAS NOT HARMED DURING THIS INCIDENT. MR. SMITH STATED HE TOOK OFF RUNNING TO 6828 COLONEL GLENN RD TO CONTACT THE POLICE. MR. SMITH FURTHER STATED WHILE HE WAS RUNNING HE HEARD AN INDIVIDUAL YELLING FROM APT 52, WHO SOUNDED LIKE THE UNKNOWN SUBJECT WHO HELD HIM AT GUN POINT.

WHILE SPEAKING WITH MR. THOMAS, OTHER OFFICERS WERE CIRCULATING THE AREA. DURING THIS TIME, OFFICERS WERE ABLE TO LOCATE ALL OF THE STOLEN ITEMS BELONGING TO MR. THOMAS, IN THE PARKING LOT OF THE PARKWOOD APARTMENTS. AN ANONYMOUS INDIVIDUAL FROM APT 14 AT THE APARTMENT COMPLEX ADVISED THEY OBSERVED A B/M AND A W/F IN A MAROON LUMINA SEDAN DROP THE ITEMS OFF IN THE PARKING LOT AND LEAVE. MR. SMITH ADDITIONALLY ADDED HE REMEMBERED SEEING THAT SAME CAR PARKED WHILE HE WAS WORKING AND IT HAD "JUST SOLD" WRITTEN IN CHALK ON THE BACK WINDOW OF THE VEHICLE.

OFFICERS MADE A BROADCAST FOR THE AGGRAVATED ROBBERY SUSPECT. A SUPERVISOR WAS NOTIFIED OF THE INCIDENT. OFFICERS PROVIDED MR. SMITH WITH AN INCIDENT NUMBER. BWC AND MVR IN USE.

## NARRATIVE
