NARRATIVE

ON TODAY'S DATE, COMMUNICATIONS RECEIVED A CALL REGARDING A ROBBERY OF AN INDIVIDUAL.

UPON ARRIVAL, OFFICERS SPOKE WITH BRENTON HARRIS, WHO STATED THAT GRALIN TYLER ROBBED HIM AT GUNPOINT. HARRIS ADVISED THAT HE HAD MET WITH TYLER ON SEVERAL OCCASIONS TO SELL SHOES. HARRIS STATED THAT DURING THIS MEETING, TYLER PRODUCED A TAURUS HANDGUN, POINTED IT AT HIM, AND TOOK THE SHOES WITHOUT PAYMENT. HARRIS STATED HE DOES NOT KNOW TYLER'S DATE OF BIRTH BUT BELIEVES HE IS APPROXIMATELY TWENTY YEARS OF AGE.

HARRIS PROVIDED OFFICERS WITH A PHOTOGRAPH OF TYLER. IN THE PHOTO, TYLER APPEARED TO BE STANDING ON A BALCONY AT 9300 TREASURE HILL ROAD (TOWNE OAKS APARTMENTS). OFFICERS OBSERVED THAT THE PROFESSOR BOWL BOWLING ALLEY WAS VISIBLE ACROSS THE STREET IN THE BACKGROUND OF THE PHOTO. OFFICERS ALSO NOTICED A COUCH ON THE BALCONY WITH TYLER.
