NARRATIVE

ON JUNE 30, 2026, OFFICERS RESPONDED TO 925 FAIR PARK BOULEVARD (CIRCLE K GAS STATION) FOR WHAT WAS DISPATCHED AS A SHOOTING IN PROGRESS. OFFICERS WERE AROUND THE CORNER WHEN THE INCIDENT OCCURRED AND DID NOT HEAR ANY GUNSHOTS. COMMUNICATIONS ADVISED THE PERSON WHO CALLED 911 SAID THEY WERE BEING SHOT AT BY THE STORE CLERK.

UPON ARRIVAL, OFFICERS MADE CONTACT WITH CLARK WHO WORKS AS A CLERK AT CIRCLE K. CLARK CAME WALKING AROUND THE NORTH WEST CORNER OF THE BUILDING AS OFFICERS ARRIVED. CLARK APPEARED DISHEVELED AND HAD HAIR, WHICH LOOKED TO BE HER OWN, IN HER HAND. CLARK WAS IMMEDIATELY DISMISSIVE OF OFFICERS AND REMAINED SOME WHAT UNCOOPERATIVE. CLARK ADVISED THAT WHO WOULD BE LATER IDENTIFIED AS PRICE, WAS IN THE STORE ATTEMPTING TO STEAL CHEESE DIP. CLARK SAID SHE CONFRONTED PRICE AND HE BECAME ARGUMENTATIVE. CLARK ADVISED, ACTING AS AN OFFICIAL OF THE STORE TRYING TO RETRIEVE STORE MERCHANDISE, SHE STRUCK PRICE. PRICE WOULD NOT GO INTO MUCH MORE DETAIL. OFFICERS OBSERVED THE STORE SHELVES TURNED OVER WITH MERCHANDISE ALL ABOUT THE FLOOR AS IF TWO SUBJECTS FIGHTING HAD CRASHED IN TO THEM.

OFFICERS SIMULTANEOUSLY MADE CONTACT WITH ESELLE UPON ARRIVAL, ESELLE STATED SHE WITNESSED PRICE REPEATEDLY STRIKING CLARK. ESELLSE STATED NO ONE FIRED SHOTS AND NO FIREARM WAS INVOLVED. A SECOND WITNESS, WHO OFFICERS FAILED TO IDENTIFY DUE TO THE CHAOS OF THE SCENE AND HIS SPEEDY EXIT, ALSO STATED HE OBSERVED PRICE STRIKING CLARK AND MADE NO MENTION OF A FIREARM BEING INVOLVED.

CLARK STATED SHE DID NOT WANT TO PRESS CHARGES. CLARK ATTEMPTED TO CONTACT HER STORE MANAGER ABOUT THE ROBBERY WHICH HAD OCCURRED BUT WAS UNABLE TO GET ANYONE ON THE PHONE.

AFTER OFFICERS HAD BEEN ON SCENE FOR SEVERAL MINUTES, THEY WERE FLAGGED DOWN BY PRICE WHO WAS SITTING IN THE DARK ACROSS THE STREET. PRICE'S SHIRT WAS TORN, HE HAD A VERY SMALL CUT ABOVE HIS LEFT EYE, AND SMALL SCRATCHES ON HIS ARMS AND LEGS.

PRICE ADVISED CLARK ACCUSED HIM OF STEALING AND THE TWO BEGAN TO ARGUE. CLARK THEN ALLEGEDLY PRODUCED A BRICK IN A SOCK AND STRUCK HIM IN THE HEAD WHILE HE WAS STANDING ACROSS THE COUNTER FROM CLARK. PRICE STATED HE THEN, IN SELF DEFENSE, RAN AROUND THE COUNTER AND HELD CLARK DOWN ON THE GROUND. PRICE THEN STATED CLARK PRODUCED A FIREARM AND CHASED HIM AROUND THE NORTHWEST CORNER OF THE BUILDING.

PRICE MADE NO MENTION OF STRIKING CLARK, CRASHING INTO THE SHELVES, OR BEING SHOT AT LIKE HE HAD TOLD THE 911 OPERATOR. PRICE ALSO STATED HE NEEDED TO TURN OFF THIS VERSION OF HIMSELF AND TURN ON ANOTHER AND THEN STATED HE HEARD BLUE GOLD AND GREEN. PRICE TOLD OFFICERS CLARK BROKE A TOOTH OUT OF HIS MOUTH BUT ALL OF HIS TEETH WERE INTACT. WHEN OFFICERS ARRIVED ON SCENE, THEY OBSERVED CLARK RETURNING FROM WHERE SHE ALLEGEDLY CHASED PRICE WITH A FIREARM. CLARK WAS UNARMED. PRICE IS A KNOWN SCHIZOPHRENIC SUBJECT.

OFFICERS CONTACTED AN ON-DUTY PATROL SUPERVISOR WHO CONTACTED MAJOR CRIMES. DUE TO THE MAIN WITNESS BEING UNCOOPERATIVE AND OFFICERS BEING UNABLE TO CONTACT A STORE MANAGER TO REVIEW FOOTAGE OR ADVISE IF THE STORE WOULD BE A VICTIM, DETECTIVES WERE NOT CALLED OUT AND PRICE WAS NOT TAKEN INTO CUSTODY. PRICE WAS HOWEVER BANNED FROM 925 FAIR PARK BOULEVARD AND ADVISED SHOULD HE RETURN; HE WOULD BE ARRESTED FOR CRIMINAL TRESPASS. PRICE WAS SEEN BY MEMS BUT WAS NOT TRANSPORTED TO THE HOSPITAL. MVR AND BWC IN USE 23C769.

OFFICERS RESPONDED TO A THEFT CALL AT THE LISTED LOCATION. OFFICERS MADE CONTACT WITH MS. LECREESHA THOMAS WHO ADVISED SHE WAS PICKING HER CHILDREN UP FROM THE LITTLE ANGELS CHILDCARE CENTER WHEN AN UNKNOWN BLACK FEMALE CLIMBED INTO HER VEHICLE IN THE PARKING LOT AND ATTEMPTED TO DRIVE OFF IN IT.

MS. THOMAS ADVISED SHE HAD JUST PLACED HER 3 Y/O SON IN THE BACKSEAT WHEN SHE REALIZED A WOMAN WAS IN THE CAR. MS. THOMAS ADVISED THE WOMAN THEN TRIED TO DRIVE AWAY, BUT MS. THOMAS MANAGED TO COME AROUND TO THE DRIVER'S SIDE DOOR AND PULL THE WOMAN OUT BY HER HAIR.

MS. THOMAS ADVISED THE WOMAN REPEATEDLY GOT BACK IN THE VEHICLE, ATTEMPTING TO DRIVE OFF IN IT. MS. THOMAS ADVISED HER JEEP WOULD NOT LOCK. MS. THOMAS ADVISED SHE GRABBED HER 3 Y/O SON OUT OF THE JEEP AND GAVE HIM TO THE CHILDCARE CENTER DIRECTOR, WHO HAD WITNESSED THE WHOLE ALTERCATION.

MS. THOMAS ADVISED AFTER THE THIRD TIME OF PULLING THE WOMAN OUT, THE WOMAN BEGAN FIGHTING BACK AND MS. THOMAS HAD TO PUNCH HER IN THE FACE. MS. THOMAS ADVISED SHE ONLY PUNCHED THE WOMAN ONCE. MS. THOMAS ADVISED THE WOMAN BEGAN BLEEDING FROM HER NOSE AND MOUTH.

MS. THOMAS ADVISED THE WOMAN WAS BLACK, ABOUT 5'11", DARK COMPLEXION, BRAIDED BROWN HAIR, WEARING A GREEN AND BLACK CROP TOP, AND BLUE LEGGINGS.

MS. THOMAS ADVISED SHE THOUGHT HER THUMB WAS BROKEN FROM THE ALTERCATION BUT DECLINED MEDICAL ATTENTION.

OFFICERS PROVIDED MS. THOMAS WITH AN INCIDENT NUMBER AND ADVISED DETECTIVES WOULD VIEW THE REPORT AND CONTACT HER. OFFICERS CHECKED THE LITTLE ANGELS CHILDCARE CENTER FOR CAMERAS, OBSERVING ONE ON THE CORNER OF THE BUILDING, AS WELL AS A RING DOORBELL CAMERA ON THE FRONT DOOR OF THE DAYCARE.

OFFICERS PUT OUT A BROADCAST FOR THE SUSPECT.
