NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO A REPORTED ROBBERY. UPON ARRIVAL, OFFICERS MADE CONTACT WITH SONYA SCOTT, WHO STATED THAT A WHITE FEMALE KNOWN TO HER AS KIM AND A BLACK MALE KNOWN TO HER AS DERREL PUSHED HER TO THE GROUND AND STOLE \$800 FROM HER. THE ORIGINAL CALL NOTES INDICATED THAT \$8,900 HAD BEEN TAKEN; HOWEVER, SCOTT CLARIFIED THAT THE AMOUNT WAS \$800.

WHILE SPEAKING WITH SCOTT, OFFICERS FOUND IT DIFFICULT TO UNDERSTAND HER DUE TO HER HEAVILY SLURRED SPEECH, WHICH APPEARED TO BE CONSISTENT WITH POSSIBLE INTOXICATION OR IMPAIRMENT. SHE WAS UNABLE TO PROVIDE MUCH USEFUL INFORMATION REGARDING THE INCIDENT, INCLUDING IDENTIFYING INFORMATION FOR THE SUSPECTS OR THEIR DIRECTION OF TRAVEL, OTHER THAN STATING THAT THEY LIVED IN THE WOODS.

AN ACIC CHECK REVEALED THAT SCOTT HAD A FEDERAL MENTAL HEALTH CAUTION. OFFICERS WERE ALSO ADVISED THAT THERE WAS NO VIDEO FOOTAGE AVAILABLE OF THE REPORTED INCIDENT.

NARRATIVE

ON SATURDAY, JULY 4, 2026, OFFICERS CONDUCTED A TRAFFIC STOP ON A RED 2016 LEXUS SUV BEARING ARKANSAS LICENSE PLATE BLY41V (V1), WHICH RESULTED IN THE FELONY ARREST OF TWO SUBJECTS.

OFFICERS OBSERVED V1 IN A PARKING LOT IN THE 8400 BLOCK OF COLONEL GLENN ROAD. OFFICERS HAD KNOWLEDGE OF JERIMIAH NORRIS BEING ASSOCIATED WITH THE VEHICLE DUE TO A WARNING ATTACHED TO THE VEHICLE'S RETURN ON JUNE 10, 2026. NORRIS WAS KNOWN TO HAVE A LITTLE ROCK AFFIANT WARRANT (LR-26-4834) FOR AGGRAVATED ROBBERY (Y-FELONY) AND THEFT OF PROPERTY OBTAINED BY THREAT OF SERIOUS PHYSICAL INJURY (B-FELONY).

V1 EXITED THE PARKING LOT AND TRAVELED WESTBOUND ON COLONEL GLENN ROAD, CONTINUING ONTO STAGECOACH ROAD. WHILE TRAVELING ON STAGECOACH ROAD, OFFICERS OBSERVED V1 CROSS THE DOUBLE YELLOW CENTER LINE. A TRAFFIC STOP WAS CONDUCTED NEAR THE LISTED INCIDENT ADDRESS.

UPON APPROACHING THE VEHICLE, OFFICERS POSITIVELY IDENTIFIED NORRIS AS THE FRONT SEAT PASSENGER, ORDERED HIM OUT OF THE VEHICLE, AND TOOK HIM INTO CUSTODY WITHOUT INCIDENT. OFFICERS ALSO POSITIVELY IDENTIFIED THE DRIVER AS MR. HERBERTO SCOTT, WHO HAD ALSO RECEIVED A WARNING ATTACHED TO THE VEHICLE'S RETURN ON THE SAME DATE AS NORRIS. OFFICERS OBSERVED THAT SCOTT WAS NOT WEARING HIS SEAT BELT. OFFICERS ALSO HAD KNOWLEDGE THAT SCOTT DID NOT POSSESS A VALID DRIVER'S LICENSE.

NORRIS WAS RUN THROUGH LITTLE ROCK COMMUNICATIONS, WHO VERIFIED AND CONFIRMED THE LITTLE ROCK AFFIANT WARRANT. SCOTT WAS ALSO RUN THROUGH LITTLE ROCK COMMUNICATIONS, WHO CONFIRMED HIS LICENSE STATUS WAS NOT VALID, SHOWING A CLASS "ID" ONLY, AND ADVISED THAT HE WAS A PROBATIONER WITH AN ACTIVE SEARCH WAIVER ON FILE.

A SEARCH OF SCOTT WAS CONDUCTED, YIELDING NO CONTRABAND. OFFICERS THEN CONDUCTED A SEARCH OF V1 IN ACCORDANCE WITH THE TERMS OF HIS SEARCH WAIVER. DURING THE SEARCH, OFFICERS LOCATED A LOADED BLACK GLOCK 19 GEN 5 PISTOL (SN: BPDR505) WITH AN INSERTED EXTENDED MAGAZINE CONTAINING 22 ROUNDS OF 9MM AMMUNITION POSITIONED UNDERNEATH THE DRIVER'S SEAT, AS WELL AS ONE LOOSE .40 CALIBER ROUND IN THE FRONT PASSENGER FLOORBOARD.

A RECORDS CHECK OF SCOTT'S CRIMINAL HISTORY THROUGH ACIC/NCIC AND LITTLE ROCK COMMUNICATIONS REVEALED THAT HE WAS A CONVICTED FELON BASED ON A FELONY THEFT CONVICTION ON APRIL 13, 2026. THE FIREARM'S SERIAL NUMBER WAS ALSO RUN THROUGH ACIC/NCIC AND LITTLE ROCK COMMUNICATIONS AND WAS FOUND TO HAVE BEEN REPORTED STOLEN OUT OF LITTLE ROCK UNDER REPORT NUMBER 2026-046320.

V1 WAS TOWED BY ROUTH WRECKER TO THE LITTLE ROCK CITY IMPOUND LOT IN ACCORDANCE WITH LRPD POLICY. NORRIS WAS TRANSPORTED TO THE PULASKI COUNTY REGIONAL DETENTION FACILITY, WHERE HE WAS SERVED WITH THE AFFIANT WARRANT. SCOTT WAS ALSO TRANSPORTED TO THE DETENTION FACILITY, WHERE HE WAS CHARGED WITH POSSESSION OF FIREARMS BY CERTAIN PERSONS (B-FELONY), THEFT BY RECEIVING-FIREARM (D-FELONY), NO DRIVER'S LICENSE, NO SEAT BELT, AND DRIVING LEFT OF CENTER.

THE GLOCK 19 GEN 5 PISTOL, 22 ROUNDS OF 9MM AMMUNITION, AND ONE .40 CALIBER ROUND WERE STORED INTO THE SOUTHWEST PROPERTY ROOM AS EVIDENCE. NO FURTHER INCIDENT OCCURRED. MVR/BWC IN USE.
