NARRATIVE

WRIGHT STATED WHEN SHE OPENED THE SHED, TAPLIN WAS HUNKERED DOWN INSIDE AND JUMPED UP AT WRIGHT AND STATED "WHAT ARE YOU DOING BITCH?" WRIGHT STATED SHE TRIED TO GET HER BACKPACK AND TAPLIN TOOK IT FROM HER. TAPLIN TOLD WRIGHT " I WANT TO FUCK." WRIGHT TOLD HIM SHE JUST WANTS HER BACKPACK. TAPLIN TOLD HER IF YOU GIVE ME A CIGARETTE I WILL GIVE YOU THE BACKPACK. WRIGHT STATED TAPLIN TOOK THE CIGARETTE AND WOULD NOT GIVE HER THE BACKPACK. WRIGHT STATED TAPLIN THEN STRUCK HER WITH HIS FIST IN THE FACE AND TOOK THE BACKPACK AND RAN OFF. WRIGHT HAD A LARGE RED MARK ON THE RIGHT SIDE OF HER FACE. SHE HAD HAND PRINT MARKS ON HER ARM WHERE HE WAS GRABBING ONTO HER ARMS TRYING TO HOLD HER IN THE SHED. SHE HAD SEVERAL BRUISES AS WELL ON HER ARMS AND LEGS.
