NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION IN REFERENCE TO AN UNKNOWN TROUBLE. COMMUNICATIONS ADVISED THERE WERE MULTIPLE CALLS ADVISING SHOTS HEARD IN THE AREA AND A CALLER ADVISED HER SISTER WAS ASSAULTED AND A WHITE MALE FIRED SHOTS AT THEM AT THE LISTED LOCATION. UPON ARRIVAL OFFICERS OBSERVED A BROKEN FRONT WINDOW TO THE EAST SIDE OF THE RESIDENCE. CONTACT WAS MADE WITH VICTIM, MS. ELIZABETH VELAZQUEZ, WHO ADVISED SHE WAS PHYSICALLY ASSAULTED BY MS. JAMIE DUNCAN AND FRIEND WHILE SHE WAS SLEEPING IN A SILVER ACURA SUV ON THE WEST SIDE OF RESIDENCE. MS. VELAZQUEZ STATED SHE WAS AWAKEN TO PUNCHES TO HER HEAD PRIOR TO BEING DRUG OUT OF THE VEHICLE. MS. VELASQUEZ ADVISED SHE DEFENDED HERSELF AGAINST THE TWO WOMEN PRIOR TO LEAVING THE AREA, ON FOOT, HEADED NORTHBOUND ON JOHN BARROW RD TO RODNEY PARHAM RD. MS. VELASQUEZ STATED ONCE SHE WAS ABLE TO MAKE CONTACT WITH HER GODMOTHER, MS. ANGELA PERRY, AND GOD SISTER, MS. AIYANNA BRITTON, SHE ADVISED THEM ON WHAT OCCURRED AND HAD THEM TO DRIVE HER BACK TO THE LISTED LOCATION TO RETRIEVE HER PHONE WHICH WAS TAKEN DURING THE ASSAULT. MS. VELAZQUEZ STATED WHEN THEY ARRIVED TO THE RESIDENCE, ROBERT (YAYO) PULLED OUT A BLACK .45 PISTOL AND BEGAN FIRING SHOTS AT THEM.

CONTACT WAS MADE WITH MS. BRITTON WHO STATED WHEN THEY ARRIVED TO THE RESIDENCE MS. VELAZQUEZ EXITED THE VEHICLE AND WENT TO KNOCK ON THE DOOR. MS. BRITTON ADVISED ROBERT OPENED THE DOOR TELLING MS. VELAZQUEZ, "BITCH WHAT YOU DOING HERE? GET THE FUCK AWAY FROM HERE BITCH." MS. BRITTON STATED MS. VELAZQUEZ TOLD ROBERT SHE WAS TRYING TO GET HER PHONE BACK. MS. BRITTON ADVISED ROBERT PULLED OUT A BLACK PISTOL AND BEGAN SHOOTING AT THEM, SO THEY RAN AWAY FROM THE LOCATION. MS. BRITTON ADVISED HER VEHICLE WAS PARKED IN FRONT OF THE RESIDENCE FACING EASTBOUND, AND HER MOTHER, MS. PERRY, AND LITTLE BROTHER, MALIK BRITTON, WAS INSIDE.

MS. PERRY TOLD OFFICERS WHEN THEY PULLED UP TO THE RESIDENCE MS. VELAZQUEZ WENT TO ASK ROBERT FOR HER PHONE. MS. PERRY STATED SHE HEARD ROBERT SAY, "BITCH MOVE", AND THEN OPENED FIRE ON THEM. MS. PERRY ADVISED SHE JUMPED FROM THE PASSENGER SEAT TO THE DRIVER SEAT AND MOVED THE VEHICLE. SHE STATED WHEN ROBERT BEGAN SHOOTING, MALIK EXITED THE VEHICLE AND RAN IN AN UNKNOWN DIRECTION.

OFFICERS ATTEMPTED TO MAKE CONTACT WITH ROBERT, WITH NEGATIVE RESULTS. MULTIPLE .45 CALIBER SPENT SHELL CASINGS WERE OBSERVED IN THE DRIVEWAY/CARPORT OF THE RESIDENCE. THE SCENE WAS SECURED AND MAJOR CRIME DETECTIVES WERE NOTIFIED. MS. VELAZQUEZ, MS. BRITTON, AND MS. PERRY WERE TRANSPORTED TO MAJOR CRIMES TO SPEAK WITH DETECTIVES. A SEARCH WARRANT WAS COMPLETED FOR THE RESIDENCE. A S.W.A.T CALL-OUT WAS INITIATED AND THEY RESPONDED THE RESIDENCE TO ASSIST MAJOR CRIMES DETECTIVES WITH SERVING THE WARRANT. SIX INDIVIDUALS, INCLUDING ROBERT PERRY AND JAMIE DUNCAN WERE DETAINED FROM THE SEARCH AND TRANSPORTED TO 12TH STREET TO SPEAK WITH DETECTIVES. ROBERT WAS CHARGED WITH 4 COUNTS OF AGGRAVATED ASSAULT, 3 COUNTS OF TERRORISTIC ACT, 1 COUNT OF FIREARM BY CERTAIN PERSONS, AND TRANSPORTED TO PULASKI COUNTY REGIONAL JAIL. MR. MASHBURN (FTP WARRANT #LR26-4528) AND MS. KOHLMON (FTA WARRANT #LR26-1316) WERE GIVEN CITATION TO APPEAR AND A COURT DATE FOR THEIR WARRANTS. AFTER FURTHER INVESTIGATION MS. DUNCAN WAS CHARGED WITH BATTERY 2ND DEGREE, INTERFERENCE WITH EMERGENCY COMMUNICATIONS, AND ALSO TRANSPORTED TO PULASKI COUNTY REGIONAL JAIL WITHOUT INCIDENT.
