ON TODAY'S DATE, OFFICERS RESPONDED TO THE ABOVE LISTED LOCATION IN REFERENCE TO A CRIMINAL MISCHIEF. OFFICERS MADE CONTACT WITH ELVIS VICENTE. VICENTE ADVISED OF A SHOOTING THAT JUST OCCURRED TARGETING HIS HOME ADDRESS. VICENTE PROVIDED CAMERA FOOTAGE. THE CAMERA FOOTAGE SHOWS A RED PICKUP TRUCK DRIVING SOUTHBOUND ON DOYLE SPRINGS. IT SHOWS THE DRIVER SHOOTING A FIREARM IN THE DIRECTION OF VICENTES HOME. IT WAS UNCLEAR OF THE MAKE AND MODEL OF THE RED PICKUP TRUCK. I DID OBSERVE TWO GUN FIRE STRIKES ON THE LISTED STRUCTURE. A SOUTHWEST SUPERVISOR AND DETECTIVES WERE NOTIFIED. VICENTE DID NOT ADVISE OF ANY INJURIES OF THE TIME OF THIS INCIDENT. THE SPENT SHELL CASINGS FOUND WERE STORED AT THE SOUTHWEST SUBSTATION BY 3X93. MVR IN USE.

NARRATIVE

OFFICERS ARRIVED AT THE LISTED ADDRESS FOR A REPORT OF SHOTS FIRED. OFFICERS MET WITH MR. HE CAN BE CLEARLY HEARD ON VIDEO SAYING, "THIS IS A ROBBERY, GIVE ME THE MONEY". THE SUSPECT THEN FIRES A SINGLE ROUND, GRABS TWO PACKAGES OF SNACKS FROM THE COUNTER, EXITS THE BUSINESS AND FLEES HEADING EAST.
