NARRATIVE

OFFICERS HEARD MULTIPLE GUNSHOTS IN THE AREA AND LOCATED THEM AT 800 BROADWAY STREET. GUNSHOTS WERE ACTIVELY BEING FIRED AMONG A LARGE CROWD OF CARAVANING VEHICLES. OFFICERS MADE CONTACT WITH GRAHAM AND GRAVES WHO ADVISED THEY HAD BEEN OCCUPYING VEHICLE 1 IN THE PARKING LOT OF 800 BROADWAY STREET AMONGST A LARGE CROWD OF PEOPLE. THEY ADVISED AN UNKNOWN SUSPECT DREW A FIREARM AND BEGAN FIRING IT NORTH ACROSS THE PARKING LOT AND STRUCK VEHICLE 1 WHILE BOTH VICTIMS WERE INSIDE.

GRAHAM AND GRAVES WERE NOT INJURED. OFFICERS OBSERVED DAMAGE ON VEHICLE 1. OFFICERS OBSERVED FUSUS CAMERA FOOTAGE OF THE INCIDENT, LOCATED SPENT SHELL CASINGS ON THE STREET AND PARKING LOT, AND LOCATED A PROJECTILE IN THE PARKING LOT.

MORRIS MADE CONTACT WITH OFFICERS AND ADVISED HE WAS ON SCENE IN A CROWD OF PEOPLE WHEN SHOTS RANG OUT SO HE FLED THE SCENE WITH FRIENDS. MORRIS CLAIMED TO HAVE SEEN NOTHING OF NOTE.

OFFICERS ESTABLISHED A CRIME SCENE AND NOTIFIED A SUPERVISOR. CSSU AND A DETECTIVE RESPONDED TO THE SCENE TO OBSERVE AND COLLECT EVIDENCE. THE ROADRUNNER, CENTENNIAL BANK, AND POPEYES ALL HAVE SECURITY CAMERAS THAT LIKELY HAVE FOOTAGE.
