NARRATIVE

OFFICERS RESPONDED TO A DISTURBANCE WITH A WEAPON CALL AT THE LISTED LOCATION. OFFICERS MADE CONTACT WITH MR. AMAN LALANI WHO ADVISED A CUSTOMER HAD COME IN EARLIER AND LEFT WITHOUT PAYING FOR SERVICES.

LALANI ADVISED HE FOLLOWED THE FEMALE AND THE SUSPECT OUTSIDE ASKING WHERE THE SUSPECT WAS GOING. MR. LALANI ADVISED THE SUSPECT THEN PULLED OUT A BLACK KNIFE AND TOLD MR. LALANI, "STOP FOLLOWING ME." MR. LALANI ADVISED HE BEGAN TO BACK UP WHEN THE FEMALE STATED, "HE HAS A GUN, SO GO AHEAD AND SCREW THE SCREEN IN."

MR. LALANI ADVISED THE SUSPECT SAID HIS NAME IS JACOBLY BANE. MR. LALANI ADVISED THE SUSPECT PROVIDED MR. LALANI WITH TWO SEPARATE PHONE NUMBERS, 5015391054 AND 5016905315.

DUE TO MULTIPLE CUSTOMERS HAVING ENTERED THE STORE BEFORE OFFICER ARRIVAL, OFFICERS DID NOT PULL PRINTS FROM THE DOOR OR COUNTER.

OFFICERS PUT OUT A BROADCAST FOR THE SUSPECT AND NOTIFIED A SOUTH WEST SUPERVISOR. OFFICERS CONTACTED ROBBERY DETECTIVES AND ADVISED THEM OF THE SITUATION. DETECTIVES CAME TO THE STORE AND OBTAINED A STATEMENT FROM MR. LALANI. OFFICERS PROVIDED MR. LALANI WITH AN INCIDENT NUMBER AND ADVISED HIM TO CALL THE POLICE IF HE SEES THE SUSPECT AGAIN.
