NARRATIVE

OFFICERS RESPONDED TO THE LISTED ADDRESS FOR A SHOOTING JUST OCCURRED. OFFICERS MADE CONTACT WITH BUSINESS OWNER CHRISTOPHER BUTLER AND HIS EMPLOYEES BRIANNA HEARD AND KIARA MCCROME. MS. HEARD'S DAUGHTER JUV-1 WAS ALSO PRESENT.

MR. BUTLER ADVISED A BLACK MALE CAME TO THIS LOCATION AND DISCHARGED A FIREARM INTO HIS BUSINESS AND BACKING HIS VEHICLE INTO THE BUILDING. MR. BUTLER ADVISED THE BLACK MALE, ANDERSON LEWIS IV (DOB 4-28-92), WAS A BOYFRIEND OF MS. MCCROME, ONE OF HIS EMPLOYEES.

OFFICERS SPOKE WITH MS. MCCROME. SHE ADVISED SHE WAS FILLING ORDERS IN THE KITCHEN AREA WHEN HER EX-BOYFRIEND ANDERSON LEWIS IV CAME INTO THE LOCATION WITHOUT HER KNOWLEDGE. MS. MCCROME ADVISED SHE OPENED THE TAKEOUT WINDOW AND BEGAN CAUSING A VERBAL DISTURBANCE INSIDE THE RESTAURANT. MS. MCCROME ATTEMPTED TO DE-ESCALATE THE SITUATION AND BEGGED HIM TO LEAVE BUT HE REFUSED. MS. MCCROME ENLISTED THE HELP OF ANOTHER EMPLOYEE, BRIANA HEARD. THEY BOTH DEMANDED HE LEAVE THE ESTABLISHMENT AND HE AGAIN REFUSED. BOTH MS. MCCROME AND MS. HEARD WALKED TO THE REAR OF THE RESTAURANT TO GET MR. BUTLER, THE STORE OWNER. UNBEKNOWN TO THEM, MR. LEWIS IV HAD WALKED OUT OF THE RESTAURANT, GOT INTO HIS VEHICLE, AND REVERSED IT, NEARLY TO THE FRONT DOOR OF THE BUSINESS. MS. MCCROME ADVISED MR. LEWIS, WHO WAS STILL IN HIS VEHICLE, THEN REACHED OVER TO THE OPEN PASSENGER SIDE WINDOW AND PRODUCED A SILVER HANDGUN. MS. MCCROME ADVISED HE THEN DISCHARGED THE FIREARM THROUGH THE GLASS DOOR OF THE BUSINESS MULTIPLE TIMES BEFORE FLEEING THE SCENE DRIVING WEST ON COLONEL GLENN IN A BLACK TOYOTA COROLLA WITH PAPER TAG (DB998456)

OFFICERS SPOKE WITH MS. HEARD. MS. HEARD CONFIRMED THE SEQUENCE OF EVENTS AS MS. MCCROME DESCRIBED THEM AND ADVISED HER DAUGHTER, JUV-1 WAS ALSO PRESENT DURING THIS INCIDENT. MS. HEARD ADVISED SHE HAD TO GET HER DAUGHTER TO A POSITION OF SAFETY TO AVOID INJURY.

OFFICERS SECURED THE SCENE. SGT. HAMPTON RESPONDED TO SCENE. MAJOR CRIMES WAS NOTIFIED AND RESPONDED TO SCENE. WHILE WAITING FOR CRIME SCENE PERSONNEL TO ARRIVE, ARKANSAS STATE POLICE ADVISED THEY HAD LOCATED THE SUSPECT VEHICLE AND TAKEN MR. LEWIS IV INTO CUSTODY AT 622 W MAIN ST. IN CABOT, AR. OFFICERS RESPONDED TO THE LOCATION AND TOOK CUSTODY OF MR. LEWIS IV. OFFICERS TRANSPORTED HIM TO THE 12TH STREET DETECTIVE'S OFFICE FOR AN INTERVIEW. AFTER INTERVIEWING MR. LEWIS IV WAS TRANSPORTED FIRST TO PCRJ, THEN TO UAMS AS A RESULT OF BEING IN A VEHICLE COLLISION. AFTER MR. LEWIS IV WAS MEDICALLY CLEARED, HE WAS TRANSPORTED TO PCRJ. MR. LEWIS IV WAS CHARGED WITH UNLAWFUL DISCHARGE OF A FIREARM FROM A VEHICLE 1ST (Y-FEL), 4 COUNTS OF TERRORISTIC ACT (B-FEL), 3 COUNTS OF AGGRAVATED ASSAULT (D-FEL), 1 COUNT OF AGGRAVATED ASSAULT ON A FAMILY/HOUSEHOLD MEMBER (D-FEL), AND 1 COUNT OF TERRORISTIC THREATENING (D-FEL) FOR THREATENING TO KILL OFFICERS WHILE IN CUSTODY.

THE LISTED VEHICLE, REGISTERED TO MR. LEWIS IV, WAS IMPOUNDED AND TOWED TO THE CRIME SCENE BAY. A NO FURTHER ACTION WAS TAKEN. MVR AND BWC IN USE.

NARRATIVE

OFFICERS WERE CALLED TO THE AREA FOR A SHOTS FIRED REPORT. WHEN OFFICERS ARRIVED, THERE WERE NO SUSPECT/VICTIMS THAT COULD BE LOCATED. SEVERAL REFUSED WITNESSES ADVISED THEY EITHER HEARD A SHOT(S) BEING FIRED AND EITHER A GREY OR WHITE VEHICLE WAS SEEN GOING WEST ON 8TH OR NORTH ON CUMBERLAND.

AS OFFICERS WERE PREPARED TO LEAVE THE AREA, GRIFFIN PULLED BACK INTO THE PARKING LOT AND MADE CONTACT WITH OFFICERS. SHE ADVISED THAT SHE WAS LEAVING CUMBERLAND TOWERS IN VEH-1 WITH HER BOYFRIEND, VANCER, IN THE PASSENGER SEAT. SHE ADVISED SHE TURNED NORTH ON CUMBERLAND (SOUTH BOUND ONLY) AND THEN BACK WEST ON 8TH ST. SHE ADVISED A B/M SHE ONLY KNOWS AS "FLAME" WAS IN THE PARKING LOT ON THE SW CORNER OF 8TH/CUMBERLAND. SHE STATED HE WAS YELLING SOMETHING AT HER, SO SHE STOPPED TO ROLL HER WINDOW DOWN. SHE CLAIMED HE SUDDENLY BRANDISHED A HANDGUN AND FIRED A SINGLE SHOT AT VEH-1. SHE SAID HE WALKED OFF GOING WEST THROUGH THE LOT. GRIFFIN ADVISED THAT "FLAME" MISSED HER CAR AND SHE LEFT GOING WEST ON 8TH ST.

OFFICERS BEGAN TO LOOK OVER VEH-1 AND LOCATED A SMALL HOLE IN THE FRONT BUMPER THAT APPEARED TO HAVE BEEN CAUSED BY A BULLET. OFFICERS FOLLOWED THE PATH OF TRAJECTORY THAT CONTINUED THROUGH THE BUMPER AND THROUGH THE RADIATOR BEFORE STRIKING THE ENGINE BLOCK. VEH-1 WAS LEAKING RADIATOR FLUID.

OFFICERS MADE A BROADCAST AND BEGAN TO LOOK AROUND THE AREA IN WHICH GRIFFIN SAW HIM LAST. OFFICERS LOCATED A SINGLE ROUND IN THE PARKING LOT WHERE SHE SAW HIM FIRE THE WEAPON. WHILE ON SCENE, VANCER LEFT THE AREA TO SEARCH FOR "FLAME" AFTER HE WAS ADVISED TO STAY AT THE LOCATION. HE CALLED GRIFFIN AND CLAIMED HE SAW "FLAME" NEAR BUFFINGTON TOWERS AND HAD NOW CHANGED INTO ALL BLACK WITH WHITE SHOES.

SEVERAL SUBJECTS ON SCENE ADVISED THEY THOUGHT "FLAME"'S REAL NAME IS "ANTONIO". A REFUSED COMPLAINANT ADVISED "FLAME" IS A FORMER TENANT IN CUMBERLAND TOWERS. HE WENT UPSTAIRS TO MAKE CONTACT WITH AN UNKNOWN SUBJECT AND RETURNED WITH PIERCE'S INFORMATION AS "FLAME"'S SUPPOSED IDENTITY.

MAJOR CRIMES AND SUPERVISORS RESPONDED TO THE SCENE TO CONDUCT INTERVIEWS. THE INVESTIGATION IS ONGOING.
