NARRATIVE

OFFICERS RESPONDED TO THE LISTED LOCATION REGARDING A THEFT REPORT. OFFICERS MADE CONTACT WITH VIC#1(COLE) WHO IS ARMED SECURITY FOR THE BUSINESS. COLE STATED THAT A B/M BY THE NAME OF TYLER CAME INTO THE LOCATION ASKING TO SPEAK TO A DOCTOR/MANAGER. COLE STATED HE ADVISED TYLER THAT NO ONE WAS AVAILABLE. COLE ADVISED TYLER STATED TO HAVE SOMEONE CALL HIM. COLE ASKED TYLER IF THEY HAVE HIS NUMBER AND TYLER ADVISED THEY COULD LOOK IT UP. COLE REMEMBERED THAT TYLER WAS RECENTLY TOLD HE COULD NO LONGER DONATE PLASMA A FEW DAYS AGO AND HE LEFT VERY UPSET. WHILE WALKING OUT, COLE STATED HE WAS STANDING NEAR THE EXIT AS TYLER WAS LEAVING THROUGH THE DOOR. COLE STATED TYLER THEN REACHED BACK AND GRABBED ON HIS GUN, GETTING ONE OF THE LOCKING MECHANISMS OPEN. COLE STATED TYLER YANKED AT THE GUN REALLY HARD TRYING TO GET IT OUT, WHICH HURT HIS HIP AND CAUSED HIM TO GET OFF BALANCE AND TWISTING HIS ANKLE. TYLER REALIZED HE COULD NOT GET THE GUN OUT AND TOOK OFF RUNNING THROUGH THE PARKING LOT. COLE ADVISED LUCKILY HIS HOLSTER HAD TO LOCKING MECHANISMS IN PLACE IN ORDER TO REMOVE THE GUN. COLE REFUSED MEDICAL. OFFICERS WERE ABLE TO OBTAIN A PICTURE OF TYLER WHICH WILL BE UPLOADED TO THIS REPORT. COLE AND OTHER STAFF DID NOT HAVE ACCESS TO CAMERA FOOTAGE AT THIS TIME. MVR IN USE.
