NARRATIVE

OFFICERS WERE DISPATCHED TO 1624 COLLEGE ST. IN REFERENCE TO AN ASSIST MEDICAL CALL. UPON ARRIVAL, OFFICERS MADE CONTACT WITH VIC1 (OWEN), WHO ADVISED THAT HE HAD BEEN ATTACKED AT THE KROGER LOCATED AT 1100 E. ROOSEVELT RD.

OWEN ADVISED THAT HE WAS WALKING BEHIND THE KROGER BUILDING WHEN HE WAS APPROACHED BY THREE BLACK MALES. OWEN STATED THAT ONE OF THE SUSPECTS ASKED, HEY, WHITE BOY, WHAT ARE YOU DOING OVER HERE? OWEN ADVISED THAT A FEW ADDITIONAL WORDS WERE EXCHANGED BEFORE ONE OF THE SUSPECTS STRUCK HIM ON THE LEFT SIDE OF HIS HEAD WITH A GRAY METAL LOUISVILLE SLUGGER BASEBALL BAT AND BEGAN ASSAULTING HIM.

OWEN FURTHER ADVISED THAT ANOTHER SUSPECT STRUCK HIM ON THE LEFT SIDE OF HIS BACK WITH AN UNKNOWN SQUARE-SHAPED OBJECT. OWEN STATED THAT HE WAS KNOCKED UNCONSCIOUS DURING THE ASSAULT. AFTER REGAINING CONSCIOUSNESS, OWEN ADVISED THAT HE CRAWLED TO 1624 COLLEGE ST. TO SEEK ASSISTANCE AND CONTACT POLICE.

OWEN ADVISED THAT THE SUSPECTS TOOK SEVERAL ITEMS FROM HIS PERSON, INCLUDING MISCELLANEOUS ITEMS HE HAD PURCHASED FROM KROGER, A BLACK WALLET DISPLAYING A JOKER DESIGN VALUED AT APPROXIMATELY \$1,400, A GREEN CASH APP CARD, A FIRST NATIONAL BANK DEBIT CARD, A GREEN DOT PREPAID DEBIT CARD, HIS SOCIAL SECURITY CARD, IDENTIFICATION, AN APPLE PAY CARD, A SILVER AND BLUE SEIKO WATCH VALUED AT APPROXIMATELY \$1,500, AND A 24K GOLD NECKLACE VALUED AT APPROXIMATELY \$60, BLACK STRAIGHT TALK CELL PHONE VALUED AT APPROXIMATELY \$40.

OFFICERS OBSERVED BRUISING TO OWENS LEFT EYE, THE LEFT SIDE OF HIS BACK, AND HIS LEFT KNEE.

OWEN WAS UNABLE TO PROVIDE DETAILED DESCRIPTIONS OF THE SUSPECTS. HOWEVER, HE ADVISED THAT ONE SUSPECT WAS WEARING A WHITE T-SHIRT AND CAMOUFLAGE SHORTS, ANOTHER WAS WEARING A GOLD LAKER'S JERSEY AND WHITE SHORTS, AND THE THIRD WAS WEARING A BLACK T-SHIRT AND MAROON SHORTS. OWEN WAS UNABLE TO PROVIDE ANY ADDITIONAL IDENTIFYING INFORMATION REGARDING THE SUSPECTS.

OFFICERS CIRCULATED THE SURROUNDING AREA IN AN ATTEMPT TO LOCATE THE SUSPECTS BUT WERE UNABLE TO LOCATE ANYONE MATCHING THE PROVIDED DESCRIPTIONS. OFFICERS WERE ALSO UNABLE TO REVIEW ANY AVAILABLE CAMERA FOOTAGE DUE TO THE LOCATION WHERE THE ASSAULT OCCURRED.

OWEN WAS TRANSPORTED BY MEMS TO UAMS FOR FURTHER MEDICAL EVALUATION.

NARRATIVE

OFFICERS WERE DISPATCHED TO 4200 S UNIVERSITY AVE FOR AN ASSIST MEDICAL. EMPLOYEES AT THE WAFFLE HOUSE ADVISED A WHITE MALE WAS BLEEDING FROM HIS HEAD. MR BOYLES ADVISED THEY WERE HOMELESS, BUT WHEN ASKED ABOUT FURTHER DETAILS, HE JUST ADVISED HE COULDN'T REMEMBER WHAT THEY LOOK LIKE. MR BOYLES DID NOT KNOW EXACTLY WHERE THE INCIDENT OCCURRED. HE KNEW IT HAPPENED OUTSIDE, BUT WAS UNSURE WHERE AT. HE ADVISED HE WALKED ACROSS THE STREET TO GET TO THE WAFFLE HOUSE.
