NARRATIVE

STELLA MUTONI, THE VICTIM, STATED SHE HEARD ONE LOUD "POPPING" NOISE ON AUGUST 29TH, 2026 AT APPROXIMATELY 1800 HOURS. MMS. MUTONI STATED SHE WAS ALONE INSIDE THE APARTMENT AT THE TIME SHE HEARD THE NOISE. MS. MUTONI LATER NOTICED BROKEN GLASS AND WHAT APPEARED TO BE DAMAGE FROM A BULLET PASSING THROUGH HER BEDROOM WINDOW AND CURTAIN. A PHOTO OF THE DAMAGE IS ATTACHED IN RMS FILES. THE BULLET WAS RECOVERED FROM THE FLOOR INSIDE THE BEDROOM AND STORED AS EVIDENCE. MS. MUTONI WAS PROVIDED WITH THE INCIDENT NUMBER. BUILDING MANAGEMENT WAS NOT ON SCENE, DUE TO IT BEING A SUNDAY AT THE TIME OF THE REPORT. I INFORMED MS. MUTONI TO PASS THE INFORMATION ALONG TO MANAGEMENT AND ALSO HAVE MANAGEMENT CHECK FOR POSSIBLE CAMERAS/VIDEO FOOTAGE AND TO CALL POLICE BACK IF ANYTHING IS LOCATED. A MAJOR CRIMES SUPERVISOR WAS ALSO NOTIFIED OF THE INCIDENT PRIOR TO POLICE DEPARTURE. BWC WAS IN USE.

NARRATIVE

OFFICERS RESPONDED TO A BURGLARY CALL AT THE LOCATION. ROUNDS ADVISED THAT HE WAS INSIDE OF THE APARTMENT, WHICH HE IS OCCUPYING TEMPORARILY FOR A MAXWELL WHILE SHE IS OUT OF TOWN, WHEN HE WOKE TO FIND AN UNKNOWN SUSPECT WEARING A BLACK MASK AND BLACK CLOTHING IN THE LIVING ROOM. ROUNDS CLAIMED THE SUSPECT HAD A STRAIGHT RAZOR AND A BLACK SEMIAUTOMATIC PISTOL. ROUNDS STATED THAT HE WRESTLED WITH THE SUSPECT IN SELF DEFENSE UNTIL THE SUSPECT'S MASK FELL OFF.

ROUNDS RECOGNIZED THE SUSPECT AS FORD. ROUNDS MANAGED TO FLEE INTO THE BATHROOM FROM FORD. ROUNDS ADVISED THAT FORD BROKE DOWN THE BATHROOM DOOR AND PROCEEDED TO FIGHT WITH ROUNDS AGAIN. ROUNDS DISCOVERED THE WEAPON HE BELIEVED TO BE A FIREARM WAS A BB PISTOL WHEN FORD SHOT HIM WITH IT. FORD FLED THE LOCATION IN AN UNKNOWN DIRECTION OF TRAVEL.

ROUNDS CLAIMED FORD HAD NO REASON TO ATTACK HIM AND HE DID NOT KNOW HOW FORD ENTERED THE APARTMENT. OFFICERS DID OBSERVE CUTS ON ROUNDS' ARMS, LEFT HAND MIDDLE AND RING FINGER, AND FACE. OFFICERS OBSERVED BLOOD DROPS ON THE FLOOR THROUGHOUT THE LIVING ROOM, HALLWAY, AND BATHROOM. ROUNDS ADVISED HE DID NOT WANT MEDICAL ATTENTION. ROUNDS WAS PROVIDED THE INCIDENT NUMBER. 12TH STREET SUPERVISOR WAS NOTIFIED OF THE INCIDENT.

ROUNDS DID CLAIM FORD LIVES AT 223 N TAYLOR STREET IN APARTMENT 20. OFFICERS ATTEMPTED TO MAKE CONTACT WITH NEGATIVE RESULTS. A BROADCAST WAS MADE OF THE SUSPECT INFORMATION. A SHOE WAS FOUND IN THE BATHROOM THAT ROUNDS STATED BELONGED TO FORD AND MUST HAVE FALLEN OFF IN THE FIGHT.

OFFICERS WERE UNABLE TO MAKE CONTACT WITH MAXWELL TO NOTIFY HER OF THE INCIDENT AND DAMAGES TO HER APARTMENT. THE DRY WALL NEAR THE BATHROOM DOOR WAS DAMAGED AS WELL AS THE BATHROOM DOOR.
