NARRATIVE

OFFICERS WERE DISPATCHED TO A ROBBERY OF AN INDIVIDUAL AT 1800 BROADWAY (PARIS TOWERS). UPON ARRIVAL OFFICERS MADE CONTACT WITH THE VICTIM MR. WEST IN THE LOBBY OF THE APARTMENT COMPLEX. MR. WEST ADVISED OFFICERS HE WAS ROBBED OF APPROXIMATELY \$40.00 AND PHYSICALLY ASSAULTED.

MR. WEST STATED HE WAS LURED INTO ROOM 701 IN THE SAME COMPLEX BY A FEMALE AND MALE. THE FEMALE WAS IDENTIFIED BY MR. WEST AND OFFICERS AS MS. JOHNSON. THE MALE WAS ONLY IDENTIFIED AS 'ERIC' AN UNIDENTIFIED BLACK MALE.

MR. WEST ADVISED OFFICERS THAT HE WENT TO ROOM 701 IN AN EFFORT TO PURCHASE NARCOTICS (PCP). BEING LED TO BELIEVE THE OCCUPANTS OF ROOM 701 WERE GOING TO SELL HIM PCP, MR. WEST ENTERED THE ROOM. ONCE INSIDE MR. WEST STATED HE WAS PHYSICALLY ASSAULTED BY 'ERIC' WHEN HE PINNED HIM TO THE COUCH AND PUNCHED HIM IN THE FACE BEFORE STEALING \$40.00 FROM HIM (OFFICERS OBSERVED VISIBLE SWELLING AND A SMALL LACERATION TO MR. WEST'S LIP). MR. WEST THEN FLED FROM THE ROOM LEAVING BEHIND ONE OF HIS SHOES IN THE PROCESS. MR. WEST STATED THE 'ERIC' WAS THE ONE WHO ATTACKED AND ROBBED HIM BUT ADVISED THAT MS. JOHNSON WAS PRESENT WHEN THE INCIDENT OCCURRED.

WHILE INTERVIEWING MR. WEST HE BECAME AGITATED AND ADVISED OFFICERS HE WOULD BE RETURNING TO HIS ROOM. A SECURITY OFFICER ADVISED OFFICERS THE CAMERAS ON THE SEVENTH FLOOR WERE NOT FUNCTIONING WHILE OFFICERS WERE ON SCENE. OFFICERS THEN WENT TO ROOM 701 TO MAKE CONTACT WITH THE OCCUPANTS. OFFICERS WERE ABLE TO MAKE CONTACT WITH MS. JOHNSON. MS. JOHNSON APPEARED CONFUSED BY OFFICERS PRESENCE AND CONTINUED TO ASK WHY OFFICERS WERE ON SCENE. MS. JOHNSON GAVE CONSENT FOR OFFICERS TO ENTER HER APARTMENT IN ORDER TO VERIFY THERE WERE NO OTHER OCCUPANTS. OFFICERS ADVISED PROVIDED MS. JOHNSON AN INCIDENT CARD UPON REQUEST. OFFICERS ALSO PROVIDED MR. WEST WITH AN INCIDENT CARD PRIOR TO LEAVING WITHOUT FURTHER INCIDENT.

MINOR STATED AS THE INCIDENT HAPPENED, A VEHICLE COLLIDED INTO THE REAR OF HER VEHICLE, CAUSING MINOR DAMAGE (E-CRASH REPORT UNDER SAME INCIDENT NUMBER).
