NARRATIVE

OFFICERS WERE DISPATCHED TO THE LISTED LOCATION IN REFERENCE TO A THEFT REPORT.

ONCE ON SCENE, OFFICERS MADE CONTACT WITH THE COMPLAINANT, ALMA HERNANDEZ (PR 1), AND JAYLON CHACHERE (CON 1), WHO ADVISED THERE WAS A YOUNG BLACK FEMALE WITH A JUVENILE INSIDE THE STORE STEALING ITEMS.

MR. CHACHERE ADVISED HE NOTICED THE FEMALE SUSPECT ACTING "SUSPICIOUS" AND OBSERVED HER CONCEALING MULTIPLE ITEMS IN A BAG SHE HAD ON HER CART. WHEN THE FEMALE SUSPECT WALKED AWAY FROM THE CART, MR. CHACHERE WAS ABLE TO SEE MULTIPLE STORE ITEMS, INCLUDING HAIRCARE PRODUCTS AND MEDICATION, BEING CONCEALED. MR. CHACHERE WAS ABLE TO RETRIEVE THE ITEMS BEFORE THE FEMALE SUSPECT RETURNED TO THE CART.

THE FEMALE SUSPECT REALIZED ALL OF HER ITEMS HAD BEEN REMOVED FROM INSIDE HER BAG AND WALKED BACK OVER TO THE HAIRCARE PRODUCT SECTION, WHERE SHE APPEARED TO CONCEAL ADDITIONAL ITEMS BEFORE ATTEMPTING TO LEAVE THE STORE. MR. CHACHERE REALIZED THE FEMALE SUSPECT HAD CONCEALED ADDITIONAL ITEMS INSIDE HER BAG AND ATTEMPTED TO CONFRONT HER AND RETRIEVE THE STORE'S ITEMS.

WHEN MR. CHACHERE PLACED HIMSELF IN FRONT OF THE DOORWAY, THE FEMALE SUSPECT IMPLIED FORCE BY SHOVING HIM AWAY. THE FEMALE SUSPECT THEN ENTERED AN UNKNOWN VEHICLE BEARING TEXAS TAG XMG8427, WHICH WAS LAST SEEN HEADING WESTBOUND ON COLONEL GLENN ROAD.

A BROADCAST WAS MADE REGARDING THE SUSPECT AND THE VEHICLE INVOLVED IN THE INCIDENT.

OFFICERS WERE ABLE TO REVIEW VIDEO FOOTAGE OF THE INCIDENT AND ADVISED MR. CHACHERE TO SAVE ALL RECORDINGS FOR DETECTIVES.

A SOUTHWEST SUPERVISOR WAS ADVISED OF THE INCIDENT, AND MAJOR CRIME DETECTIVES WERE NOTIFIED.

THE INCIDENT NUMBER WAS PROVIDED TO THE STORE EMPLOYEES, AND THEY WERE ADVISED TO CALL POLICE BACK TO THE LOCATION IF THE SUSPECT RETURNED.

NO OTHER ACTION WAS TAKEN AT THIS TIME. MVR AND BWC IN USE.
