NARRATIVE

OFFICER RESPONDED TO 1111 W. MARKHAM STREET (SALVATION ARMY) IN REFERENCE TO A BATTERY THAT HAD JUST OCCURRED. UPON ARRIVAL, OFFICER MADE CONTACT WITH MS. MARY COTHRAN, WHO STATED AN UNKNOWN B/M HAD PUNCHED HER IN THE HEAD AND FLED THE LOCATION PRIOR TO OFFICER'S ARRIVAL.

MS. COTHRAN STATED SHE WAS SEATED NEAR THE FRONT ENTRANCE OF THE SALVATION ARMY, LOCATED ON THE NORTHEAST SIDE OF THE BUILDING, WHEN AN UNKNOWN B/M APPROACHED HER. SHE DESCRIBED THE SUSPECT AS WEARING A WHITE, LONG-SLEEVE THERMAL-TYPE SHIRT AND KHAKI PANTS. MS. COTHRAN STATED THE SUSPECT OBSERVED HER USING A VAPE AND ASKED TO USE IT. SHE REFUSED, AT WHICH TIME THE SUSPECT CONTINUED APPROACHING HER. MS. COTHRAN STATED THE SUSPECT TOLD HER, "IF YOU WON'T LET ME USE THE VAPE, THEN I WILL JUST TAKE IT."

MS. COTHRAN STATED THE SUSPECT THEN BENT OVER AND STRUCK HER IN THE HEAD MULTIPLE TIMES WITH A CLOSED FIST. SHE STATED THE SUSPECT WAS UNABLE TO TAKE THE VAPE FROM HER AND STOPPED THE ASSAULT AFTER MR. ACIE BREWER AND MR. CLARENCE MARLOW BEGAN YELLING AT HIM TO STOP. THE SUSPECT THEN FLED THE AREA, TRAVELING SOUTHBOUND ON RINGO STREET.

MR. BREWER AND MR. MARLOW COMPLETED WITNESS STATEMENT FORMS AND STATED THEY BOTH OBSERVED THE SUSPECT STRIKING MS. COTHRAN.

OFFICER BROADCAST THE SUSPECT'S DESCRIPTION AND BEGAN CHECKING THE SURROUNDING AREA. MS. ROSA GOGLIC, WHO WAS NEAR THE INTERSECTION OF 6TH STREET AND CHESTER STREET, ADVISED SHE OBSERVED A SUBJECT MATCHING THE SUSPECT'S DESCRIPTION TRAVELING SOUTHBOUND ON RINGO STREET.

OFFICER SUBSEQUENTLY LOCATED A SUBJECT MATCHING THE DESCRIPTION, LATER IDENTIFIED AS MR. JAMES EVANS II, SEATED ON A BENCH NEAR THE INTERSECTION OF 7TH STREET AND S. RINGO STREET. MR. EVANS WAS TAKEN INTO CUSTODY AND REFUSED TO PROVIDE HIS NAME. MR. EVANS WAS FINGERPRINTED, RESULTING IN A POSITIVE IDENTIFICATION.

OFFICER RETURNED TO THE SALVATION ARMY TO MAKE CONTACT WITH MS. COTHRAN AFTER LOCATING THE SUSPECT. MR. BREWER ADVISED THAT MS. COTHRAN HAD LEFT THE LOCATION WITH HER AUNT IN A VEHICLE PRIOR TO OFFICER'S RETURN.

SGT. BUTLER WAS CONTACTED AND NOTIFIED OF THE INCIDENT.

WHILE MR. EVANS WAS BEING PLACED INTO THE REAR OF A PATROL VEHICLE FOR TRANSPORT TO PCRJ, HE SPIT BODILY FLUIDS INTO AN OFFICER'S FACE. SGT. BUTLER WAS CONTACTED AND NOTIFIED OF THE ADDITIONAL INCIDENT. MR. EVANS WAS SUBSEQUENTLY TRANSPORTED TO PCRJ WITHOUT FURTHER INCIDENT AND CHARGED WITH AGGRAVATED ASSAULT ON A LAW ENFORCEMENT OFFICER (D-FELONY) AND OBSTRUCTING GOVERNMENTAL OPERATIONS (A-MISDEMEANOR).

APPROXIMATELY ONE HOUR LATER, COMMUNICATIONS ADVISED THAT AN EMPLOYEE FAMILIAR WITH THE SURVEILLANCE CAMERA SYSTEM HAD RESPONDED TO THE LOCATION. OFFICER RETURNED TO THE SALVATION ARMY AND REVIEWED THE AVAILABLE SURVEILLANCE FOOTAGE. THE FOOTAGE DID NOT CONTAIN AUDIO.

OFFICER OBSERVED MS. COTHRAN SEATED IN THE LOCATION SHE HAD PREVIOUSLY DESCRIBED AND OBSERVED MR. EVANS APPROACH HER. MR. EVANS APPEARED TO BE YELLING AT MS. COTHRAN BEFORE APPROACHING HER. THE FOOTAGE THEN SHOWED MR. EVANS SPIT BODILY FLUIDS INTO MS. COTHRAN'S FACE, AFTER WHICH HE BENT OVER AND STRUCK HER IN THE HEAD APPROXIMATELY THREE TIMES WITH A CLOSED FIST.

OFFICER WAS ADVISED THAT THE SURVEILLANCE FOOTAGE WOULD REMAIN AVAILABLE FOR DETECTIVES TO RECOVER. OFFICER ALSO DOCUMENTED THE INCIDENT USING HIS BODY-WORN CAMERA.

MR. EVANS WAS NOT CHARGED WITH ROBBERY AT THIS TIME DUE TO MS. COTHRAN LEAVING THE LOCATION AND OFFICERS NOT BEING ABLE TO MAKE CONTACT WITH HER AGAIN. THE PHONE NUMBER SHE PROVIDED WENT STRAIGHT TO VOICEMAIL ON EVERY ATTEMPT TO CONTACT HER.

WHITE STATED WHEN HE ARRIVED AT THE LOCATION TAYLOR AND A SECOND INDIVIDUAL WAS ALREADY THERE. TAYLOR AND THE OTHER SUBJECT GOT INTO HIS VEHICLE. TAYLOR STARTED COUNTING MONEY, AS IF HE WAS GOING TO GIVE HIM A DEPOSIT. WHITE STATED AT THAT TIME THE INDIVIDUAL IN THE BACK GRABBED HIM AROUND THE NECK FROM THE BACK AND TAYLOR PUT A GUN TO THE SIDE OF HIS HEAD AND DEMANDED MONEY. WHITE STATED TAYLOR KEPT HITTING HIM IN THE SIDE OF THE HEAD WITH THE MUZZLE OF THE GUN. TAYLOR STARTED GOING THROUGH HIS POCKETS AND THROUGH THE COMPARTMENTS OF THE TRUCK. OFFICERS LOOKED THROUGH THE FACEBOOK PROFILE AND IN THE PHOTOS WAS A PICTURE OF THE SUSPECT HOLDING A HIGH SCHOOL DIPLOMA WITH THE NAME (JOHNATHON JAMICHEAL TAYLOR, JR). OFFICERS RAN THE NAME THROUGH ACIC AND THE RETURN CAME BACK TO THE INDIVIDUAL WHITE STATED ROBBED HIM.

WHITE STATED TAYLOR HAD A GLOCK PISTOL WITH AN EXTENDED MAGAZINE. WHITE STATED WHEN THE SUBJECTS GOT DONE LOOKING FOR MONEY TAYLOR TOOK HIS PHONE AND THE KEYS TO HIS VEHICLE AND THREW THEM IN THE YARD AND LEFT THE AREA IN A BLUE INFINITY QX70. UNKNOWN LPN.

OFFICES CONTACTED SGT. FRAZIER AND ADVISED HIM OF THE SITUATION. OFFICERS CONDUCTED A CITY WIDE BROADCAST.

HAMMET DESCRIBED THE FIREARM AS A BLACK HANDGUN WITH A SILVER HANDLE. HE ADVISED THAT DESPITE HIS MASK, THE MALE LOOKED FAMILIAR. HAMMET STATED THE SUSPECT WAS A REGULAR AT THE STORE AND KNOWS HIM FROM AROUND THE AREA BUT WAS UNSURE OF HIS NAME OR ADDRESS.

THE SUSPECT TOOK \$200-\$300 FROM THE CASH REGISTER AND STUFFED IT INTO ONE OF THE PLASTIC DOLLAR GENERAL BAGS. OFFICERS WERE ADVISED THE SUSPECT THEN RAN SOUTHBOUND BEHIND THE STORE.

OFFICERS WERE THEN ADVISED BY A PASSERBY OF A BLACK MALE IN A SKI MASK THAT HAD HOPPED THE FENCE WEST OF THE LOCATION AND FLED INTO THE BACK LOT OF 4709 W 65TH STREET.

OFFICERS CLEARED THROUGH THE LOT AND BEGAN TO SETUP A PERIMETER SOUTHWEST OF THE INCIDENT LOCATION. OFFICERS NOTIFIED A SUPERVISOR AS WELL AS A MAJOR CRIMES DETECTIVE WHO RESPONDED TO THE SCENE. A K9 AND DRONE WERE BOTH DEPLOYED IN THE AREA BUT THE SUSPECT WAS NOT LOCATED.

OFFICERS SECURED THE SCENE FOR CRIME SCENE UNITS BEFORE LEAVING THE SCENE WITH NO FURTHER ISSUE. MVR AND BWC WERE IN USE.
