ON THIS DATE, OFFICERS RESPONDED TO A ROBBERY OF A BUSINESS AT THE LISTED LOCATION. OFFICERS SPOKE WITH THE STORE CLERK VARUN BANDARU WHO STATED TWO MALES CAME IN THE STORE WITH MASKS ON. VARUN STATED HE TOLD THE MALES TO TAKE THEIR MASKS OFF AND THEY REFUSED. VARUN STATED HE STOOD AT THE DOOR SO THE MALES WOULD NOT WALK OUT AND STEAL THE ITEMS. VARUN STATED THE MALE WITH WHITE SHOES PUNCHED HIM IN THE FACE AND KNOCKED HIM DOWN. VARUN STATED WHILE HE WAS ON THE GROUND BOTH MALES BEGAN KICKING HIM AND THE MALE WITH BLACK SHOES PULLED OUT A BLACK PISTOL BUT DID NOT POINT IT AT HIM.

OFFICERS REVIEWED VIDEO FOOTAGE OF THE INCIDENT AND OBSERVED TWO BLACK MALES WALK UP TO THE STORE FROM BASELINE ROAD. THE FIRST MALE HAD A BLACK PUFFER JACKET, GLOVES, SKI MASK, BLACK PANTS, AND WHITE SHOES. THE SECOND BLACK MALE HAD A BLACK PUFFER JACKET, GLOVES, COVID MASK, BLACK PANTS, AND BLACK SHOES. OFFICERS OBSERVED THE MALES PICKING UP ITEMS AND PUTTING THEM IN THEIR JACKET. OFFICERS OBSERVED VARUN CONFRONT THE INDIVIDUALS ABOUT THEIR FACE COVERINGS AND THE INDIVIDUALS IGNORED HIM. OFFICERS OBSERVED THE MALE IN WHITE JORDAN'S PUNCH VARUN IN THE FACE AND BEGIN KICKING HIM. OFFICERS OBSERVED THE MALE WITH THE COVID MASK AND BLACK SHOES PULL OUT A FIRE ARM OUT OF HIS RIGHT JACKET POCKET. THE MALES THEN RAN OUT OF THE STORE AND RAN SOUTH TOWARD AUXOR ARMS APARTMENTS.
