NARRATIVE

ON THIS DATE, OFFICERS RESPONDED TO A SHOOTING AT THE LISTED LOCATION. OFFICERS ARRIVED ON SCENE AND GATHERED MORE INFORMATION. OFFICERS SPOKE WITH JOSE GONZALEZ WHO STATED HIM AND HAROLD WERE SITTING OUTSIDE THEIR FOOD TRUCK BEHIND 5820 BASELINE ROAD LIQUOR STORE WHEN A BLACK MALE IN A BLACK T-SHIRT, BLACK PANTS, AND A BLACK T-SHIRT COVERING HIS FACE APPROACHED THEM. GONZALEZ STATED THE BLACK MALE TOLD THE TWO TO "GIVE ME YOUR STUFF OR I'LL KILL YOU". GONZALEZ STATED HE TOLD THE MALE HE DID NOT HAVE ANYTHING AND THE MALE HIT HIM IN THE BACK OF THE HEAD WITH A BLACK PISTOL. GONZALEZ DESCRIBED THE PISTOL TO BE LIKE OFFICERS GLOCK BUT SMALLER. GONZALEZ STATED THE MALE WENT TO HAROLD AND HIT HIM IN THE FOREHEAD WITH THE PISTOL AND STOLE HIS WALLET AND RAN. GONZALEZ STATED THE MALE WENT SOUTH ON EL ROD TOWARDS 5813 BASELINE ROAD.

OFFICERS SPOKE WITH HAROLD WHO STATED THE SAME THING AS GONZALEZ. OFFICERS SPOKE WITH THE CALLER DENIS LOPEZ WHO STATED HIS BROTHER HAROLD WAS HIT IN THE HEAD WITH A PISTOL AND HIS WALLET WAS STOLEN. DENIS STATED THE MALE WENT SOUTH ON EL ROD TOWARDS 5813 BASELINE ROAD. DENIS STATED THERE ARE CAMERAS ON THE LIQUOR STORE AND ONE OR TWO CAMERAS ON ONE OF THE FOOD TRUCKS AT THE LOCATION. DENIS STATED HE BELIEVES IT WAS A BLACK MALE THAT THEY KNOW AS MARIO. DENIS STATED MARIO IS A 30-36 YEAR OLD BLACK MALE WHO IS HOMELESS. DENIS STATED MARIO COMES TO THE LOCATION AROUND 0100-0130 HOURS TO HELP THEM CLEAN THE AREA AND THEY PAY HIM CASH FOR DOING SO. DENIS STATED MARIO KNOWS THEIR PROCESS AND WHAT TIME THEY DO THINGS AROUND THE AREA AND WHERE THEY HANGOUT. DENIS STATED MARIO KNOWS THAT HAROLD KEEPS THE CASH ON HIM AND KNOWS WHEN THEY CLOSE THE TRUCK. DENIS STATED THERE IS NO WAY TO REACH MARIO AND THAT MARIO STAYS IN THE AREA. DENIS STATED HAROLD HAD APPROXIMATELY 150-200 DOLLARS ON HIS PERSON AND DEBIT CARDS.

OFFICERS SPOKE WITH GONZALEZ ONCE MORE WHO STATED HE DID NOT SEE THE MALE COME FROM BASELINE ROAD BY THE LIQUOR STORE. GONZALEZ BELIEVES THE SUBJECT CAME FROM NORTH OF EL ROD BY THEIR HOUSE TO THE PARKING LOT. OFFICERS ATTEMPTED TO GET VIDEO FOOTAGE FROM THEIR HOME BUT WERE UNABLE TO GET THE PLAY BACK TO WORK IN THE HOME. GONZALEZ STATED THE CAMERAS ON THE LIQUOR STORE NEAR BY WORK AND THAT IS THE WAY THE SUBJECT RAN.

HAROLD WAS TRANSPORTED TO UAMS WHERE HE WAS TREATED FOR HIS INJURIES. OFFICERS MADE A BROADCAST AND GAVE GONZALEZ AN INCIDENT NUMBER. BWC IN USE.
